Re: Navy Operable Unit Work Plan for 2004

Dear Jim:

In reviewing the work that would be undertaken in support of Operable Unit 2 activities in 2004, Arcadis Geraghty & Miller has identified a number of tasks that Northrop Grumman Corporation believes would be the Navy's responsibility in regard to its handling of all off-site (of the NGC Bethpage/NWIRP property) activities. Although we feel that you have probably already incorporated them into your planning for the upcoming year, I am sending you the following listing to ensure that nothing has been missed:

Remedial Design/Remedial Action (GM-38 Area)

1. RD/RA Work Plan - Master document discussing all elements of the GM-38 Area Groundwater Remedy.
2. Development of the Termination Criteria for GM-38 Area - potentially to be performed using modeling and/or Environmental Visualization System.

OU2 Investigation and Reporting

1. Work Plan for installing monitoring wells to delineate the eastern portion of the TVOC plume relative to South Farmingdale Water District Well 4043 per the September 26, 2003 e-mail from ARCADIS to TTNUS.
2. Installation of Eastern TVOC Plume Delineation Monitoring Wells, per Item 1.
3. Installation of Dedicated Sampling Systems and Groundwater Sampling of Eastern TVOC Plume Delineation Monitoring Wells, per Item 1.



4. Final Work Plan for the GM-75D2 Area Investigation (draft work plan was prepared by ARCADIS dated November 25, 2002 on behalf of NGSC).
5. GM-75D2 Area Investigation, per Item 4.
6. GM-75D2 Area Simulations/Alternatives Analysis – potentially to be performed using modeling and/or Environmental Visualization System.


Off-Site Monitoring Well Network
