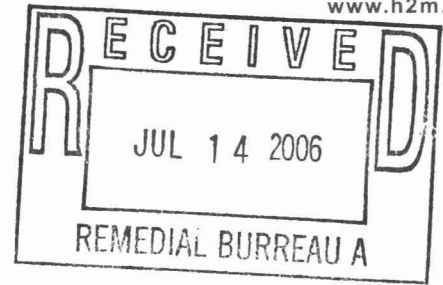

On behalf of the Town of Oyster Bay, Holzmacher, McLendon & Murrell, P.C. (H2M) is pleased to provide herein a status report on the Interim Remedial Measure for the Bethpage Community Park pursuant to Section III of the Order on Consent (Index # W1-0018-02-03).

Tasks Initiated or Completed

Tasks recently initiated or completed include the following:

- On June 14, 2006, the Town held a public information meeting to inform the public of the details of the NYSDEC approved Remedial Action Plan.
- Demolition of the existing ice rink has continued and is nearly complete.
- Contract documents including plans and specifications for implementation of the approved Remedial Action Plan were finalized and put out to public bid. Bids were opened on June 12, 2006.

Tasks to be Completed During the Next Reporting Period

Tasks expected to be initiated or completed during the next reporting period include the following:

- Ice rink demolition will be completed.
- Award of contract for implementation of Remedial Action Plan.
- Submittal to NYSDEC of various plans identified in the Remedial Action Plan approval letter.
