## **ACTION THIS MONTH**

- The New York State Department of Environmental Conservation (NYSDEC) provided a review status update
  and initial comments on the Vapor Intrusion Investigation Summary Report (ARCADIS, August 2011) for the
  Simone Development (Simone) building complex and the Metals Soil Delineation Summary Report
  (ARCADIS, September 2011) in September 13, 2011 e-mail correspondence to Bayer.
- The NYSDEC provided formal comments on the Metals Soil Delineation Summary Report in a September 16, 2011 letter to Bayer.
- ARCADIS continued preparing the exhibits portion of the Proposed Remedial Alternative Plan (PRAP) per the
  request of the NYSDEC. On behalf of Bayer, ARCADIS agreed to complete the PRAP for the NYSDEC
  following completion of the Corrective Measures Study (CMS) Report.
- ARCADIS completed revisions to the CMS Report and provided it in September 23, 2011 e-mail correspondence to Bayer for review.
- Bayer participated in a September 29, 2011 conference call with the NYSDEC and ARCADIS to discuss the project status and upcoming activities.

## **DELIVERABLES THIS MONTH**

- ARCADIS submitted the metals soil delineation summary report to the NYSDEC on September 2, 2011.
- ARCADIS submitted the Simone building complex VI investigation and the metals soil delineation electronic data deliverables (EDDs) to the NYSDEC EQuIS database on September 2 and 3, 2011, respectively.

# **ACTION NEXT MONTH**

- Revise the CMS Report based on Bayer and Simone comments and submit the final document to the NYSDEC.
- Complete the preparation of the PRAP exhibits and submit them to the NYSDEC.
- Schedule an aerial fly-over of the Site for development of a topographic map to document topography prior to construction of the final remedial measure.

## **SCHEDULE CHANGES**

There were no significant schedule changes in September 2011.
