Bayer MaterialScience LLC – 125 New South Road, Hicksville, New York Weekly Progress Meeting Summary – February 27, 2013

This memorandum summarizes items discussed during the February 27, 2013 weekly progress meeting for the Operable Unit 4 remedial activities being performed at the Bayer MaterialScience LLC (Bayer) site located at 125 New South Road in Hicksville, New York (the Site). The remedial activities are being implemented by Bayer's remedial contractor (EQ) with onsite construction/engineering oversight provided by ARCADIS.

HEALTH AND SAFETY MOMENT

• Dave Kingsley of ARCADIS discussed cold stress and provided the group with various preventative measures (e.g., diet, work schedule, clothing).

SAFETY/SAFE WORK PRACTICES

 EQ indicated that they held daily tailgate meetings and all work has progressed safely with no incidents. EQ also noted that all of the personnel working at the site have had their necessary physicals and are approved for work.

AIR MONITORING

• Preferred Environmental (Preferred) started preparing for air monitoring activities and planned to perform a test run on February 28, 2013.

REVIEW/APPROVAL OF PRIOR MEETING MINUTES

ARCADIS indicated that meeting minutes will be distributed to the project team after the weekly progress meetings.

REVIEW OF WORK PROGRESS

- EQ completed mobilization of two field office trailers and began coordinating an electrical drop to service these trailers. Generators are planned for interim power.
- EQ mobilized personnel, sanitary facilities, a storage container, hand tools, and an excavator and loader to the site.
- EQ provided a health and safety orientation to their site personnel.
- EQ's utility locating subcontractor (NAEVA Geophysics) began geophysical survey of the site and marking out subsurface utilities. EQ has not completed a notification to Dig Safely New York for the work at the site.

ARCADIS

- Ms. Julia Schneider of Cashin, Spinelli & Ferretti, LLC (CSF)(representing the Town of Oyster Bay) visited the site on February 19, and 21, 2013 and Mr. Steven Scharf of the New York State Department of Environmental Conservation (NYSDEC) visited the site on February 21, 2013.
- Long Island Power Authority (LIPA) was onsite to assess and initiate the new service drop to power
 the field office trailers and to abandon the electrical service to the Administration Building (which will
 be demolished following pre-demolition removals and permitting with the Town of Oyster Bay).
- EQ continued to address comments on the Operations Plan and Survey Control Plan provided by ARCADIS. Once the submittals are revised, ARCADIS will forward the Operations Plan, Contingency Plan, Health and Safety Plan, and Critical Path Method Schedule to the NYSDEC.

PROPOSED WORK ACTIVITIES

EQ's four-week "look ahead" schedule is included as Attachment A and summarized below:

- · Continue mobilization of personnel, equipment, and materials.
- Install the NYSDEC project sign and no-trespassing signs.
- · Conduct vegetation clearing within work areas.
- Complete the geophysical survey to locate subsurface utilities.
- Begin pre-construction site surveying activities.
- Submit EQ's Operations Plan, HASP, and Contingency Plan to the NYSDEC.
- Continue working with LIPA for the power drop to the trailers, and mobilize and operate generators for interim power.
- Begin installation of erosion and sediment controls.

OPEN DISCUSSION

- The NYSDEC asked the group what was being done for verification sampling of the proposed excavation areas and ARCADIS summarized the sampling program proposed in the Remedial Design.
- CSF asked Bayer if there was a time frame for potential use of the rail spur. Bayer indicated that they
 do not anticipate encountering hazardous material during the remedial activities and the rail spur may
 not be used.

ARCADIS

- The NYSDEC inquired when excavation activities will start and EQ indicated that it would be starting within the next few days.
- The NYSDEC asked if power was going to be installed in the job trailers, and EQ indicated it would be installed within the next few weeks.
- The NYSDEC discussed the Resource Conservation and Recovery Act (RCRA) Permit closure and indicated that the Bayer site was under Interim Status and that the closure will take place after completion of the Final Engineering Report.
- EQ asked if it was necessary to survey the verification sampling locations provided in the RD prior to
 performing excavation activities and ARCADIS indicated it was not necessary. EQ indicated they will
 collect samples from the proposed locations in the RD, approximating the proposed sample locations,
 and will survey all actual sample locations. The NYSDEC agreed with the approach.
