MONTHLY PROGRESS REPORT – OCTOBER 2013

OPERABLE UNIT 04 REMEDIAL ACTION BAYER MATERIALSCIENCE LLC 125 NEW SOUTH ROAD HICKSVILLE, NEW YORK

ACTION THIS MONTH

- ARCADIS continued to perform weekly inspections of the erosion and sedimentation control measures that were installed for the Phase 1 Operable Unit 4 (OU4) remedial construction work. Inspections are scheduled to continue through the temporary shut-down of remedial activities.
- The New York State Department of Environmental Conservation (NYSDEC), New York State Department of Health (NYSDOH), Bayer, and ARCADIS participated on an October 15, 2013 conference call to discuss the Phase 2 delineation soil sampling results, proposed additional PCB delineation (refinement), arsenic soil data/remediation strategy, and the project schedule.
- ARCADIS coordinated with its subcontractor, Muñoz Engineering & Land Surveying, P.C. to start the field portion of the ALTA/NYSDEC-specification boundary survey, and identified an abstract company for acquiring the Abstracts of Title for consideration in developing the survey for the Environmental Easement.
- ARCADIS submitted the “draft” *2013 Phase 2 Delineation Soil Sampling Summary, Proposed PCB Delineation Refinement and Verification for Soil Remediation, and Proposed Arsenic Soil Cleanup Modification* letter report to Bayer on October 31, 2013 for review.
- ARCADIS started preparing figures showing proposed Phase 2 OU4 excavation areas to be included in the Remedial Design (RD) Addendum.

DELIVERABLES THIS PERIOD

- October 2, 2013 e-mail correspondence to Cashin Spinelli & Ferretti, LLC (representing the Town of Oyster Bay) providing a project status update.

ACTION NEXT MONTH

- Submit the “draft” *2013 Phase 2 Delineation Soil Sampling Summary, Proposed PCB Delineation Refinement and Verification for Soil Remediation, and Proposed Arsenic Soil Cleanup Modification* letter report to the NYSDEC on November 7, 2013 for review.
- Participate on a November 15, 2013 telephone conference call with the NYSDEC and Bayer to discuss any comments on the above-referenced letter report.
- Perform an additional round of delineation/verification soil sampling at the site during the week of November 18, 2013. Results will be used in developing the OU4 Phase 2 RD Addendum.
- Perform the field portion of the ALTA/NYSDEC-specification boundary survey and order the Abstracts of Title.

- Work on the RD Addendum that will outline the scope of the Phase 2 OU4 remedial action.

SCHEDULE CHANGES

Phase 2 OU4 remedial construction work is anticipated to be performed after: (1) Phase 2 delineation soil sampling is completed and results are evaluated; (2) the RD Addendum is prepared by Bayer/ARCADIS and approved by the NYSDEC; and (3) Bayer completes Contractor procurement for the Phase 2 OU4 remedial action. A revised detailed schedule for implementing upcoming work is presented in the “draft” *2013 Phase 2 Delineation Soil Sampling Summary, Proposed PCB Delineation Refinement and Verification for Soil Remediation, and Proposed Arsenic Soil Cleanup Modification* letter report.
