Order on Consent and Administrative Settlement Index #A1-0799-12-10 Operable Unit 5, RUCO Polymer Corp, Hicksville, NY (Site # 130004)

GHD, on behalf of Covestro (fka Bayer Material Science LLC) and Glenn Springs Holdings, Inc. (GSH), has prepared this submittal which provides the monthly progress report for October 2015. This submittal covers Operable Unit 5 (OU-5) activity. The OU-5 Order on Consent became effective on September 30, 2013.

# Actions performed during the Reporting Period

- The September 2015 progress report for OU-5 was submitted to the NYSDEC on October 7, 2015.
- A Purchase Order was issued to Aquifer & Drilling on September 30. LIRR comments on the ADT insurances were addressed by October 30. Installation of the remaining Phase 2 probes is planned to be performed in November subject to availability of LIRR personnel to perform the underground locates and provide staff to observe the probe installations.

# Actions anticipated to be performed in the Next Month

- It is planned to install VP-43, VP-44, and VP-45 in November subject to the availability of LIRR personnel.
- 2. Resample VP-1, VP-30, and all Phase 2 probes after VP-43, VP-44, and VP-45 are installed.

#### Approved Modifications to Work Plans/Schedule

- 1. Approved modifications to the Work Plans or schedule are:
  - To collect and analyze a second set of samples from the Phase 2 probes after installing VP-43, VP-44, and VP-45.
  - ii) To submit the final report after receipt of the second set of results from the Phase 2 probes.

1. No results were generated in October.
