



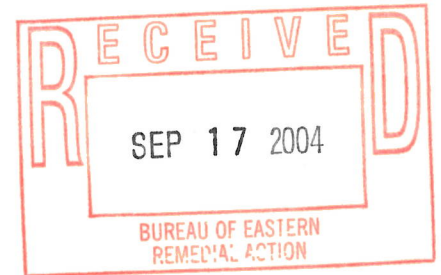



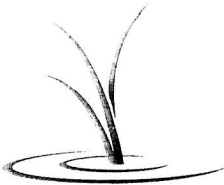

- Evaluation of the placement and design of the UVB pilot test well.

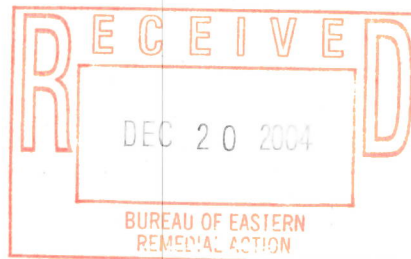
