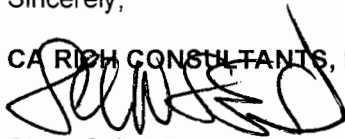
Attached are the sample results for the sanitary system associated with the above-referenced premises. Sample ID # PCP-01 refers to the primary cesspool bottom sediment, sample ID # SCP-02 refers to the bottom sediment from the secondary cesspool and sample ID # CP-01(L) refers to the standing liquid in the primary cesspool. The secondary cesspool did not contain any standing liquid. All samples were collected in the presence of Wayne Kempfski of your Office. Also attached please find a copy of the letter to Peter Witkowski (Cedar Creek W.P.C.P) that requests approval for the liquid wastewater to be accepted at the County's Cedar Creek Water Pollution Control Plant.

Based upon these sample results the two (2) cesspools will be cleaned out in accordance with Nassau County Department of Health On-site Sanitary Abandonment Procedures. Enclosed please find Figure 1 which illustrates the location of the cesspools. We are currently awaiting approval from a solid waste disposal facility to accept the solid waste. Once we receive approval, we will mobilize a high vacuum Guzzler® and a liquid pump truck to the Site to cleanout both cesspools. We will notify the Department once the work is scheduled so that you have an opportunity to witness the cleanout and have the option to collect split endpoint soil samples.

We have also enclosed the required Nassau County plan review fee of \$125. If you have any questions or need additional information, please do not hesitate to call our Office.

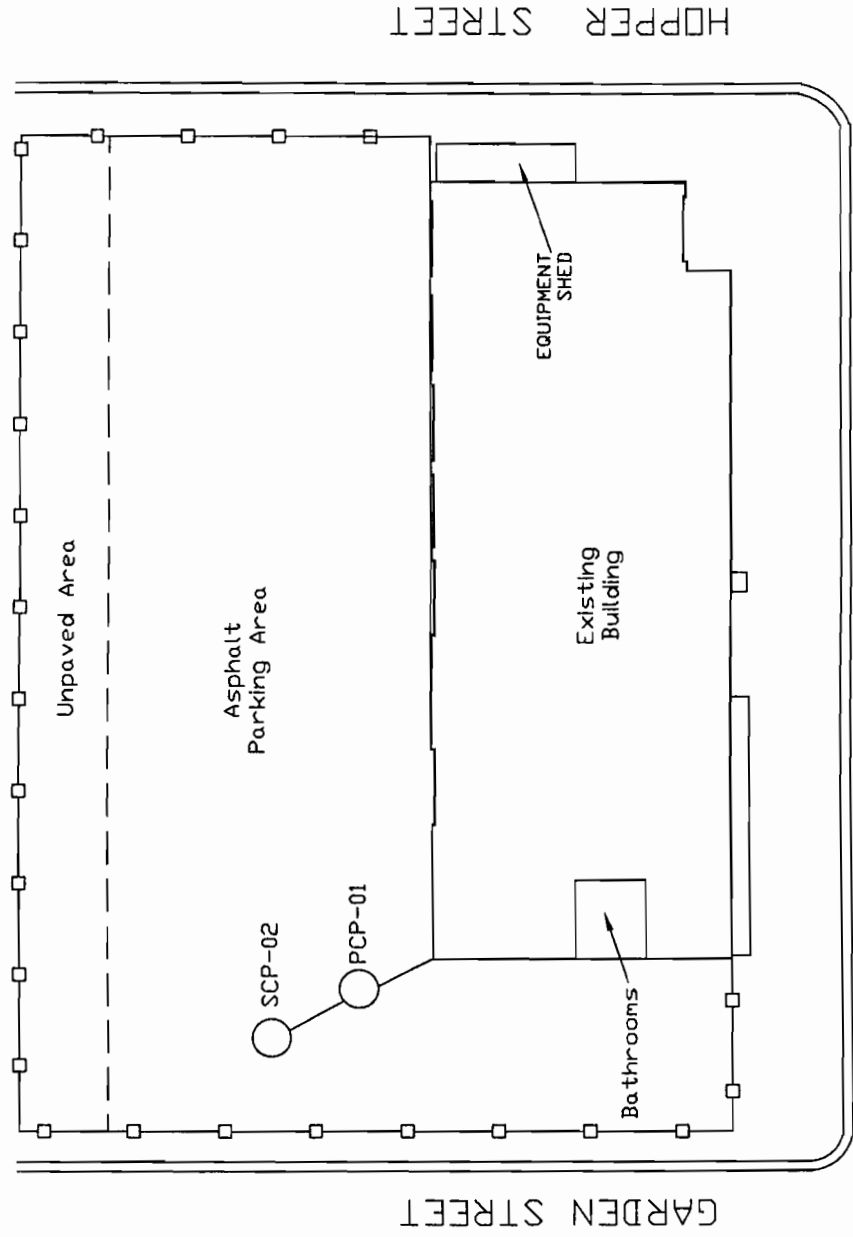
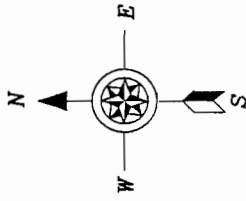
