Re: Pall Corporation – 30 Sea Cliff Avenue Site, Glen Cove, NY Meeting Request

Dear Ms. Rusinko:

This is to request a meeting with the Department the week of January 30, 2006 to discuss the results of Pall Corporation's recent groundwater monitoring at the 30 Sea Cliff Avenue site in Glen Cove, New York (the "Site"). Pall Corporation representatives, Mary Ann Bartlett and Farsad Fotouhi, Daniel Smith of Apex Environmental, and I are available to meet January 30, February 2 or February 3 either in Tarrytown or Albany, at your convenience.

You will recall that in June and July 2004 Pall raised serious concerns about groundwater contamination flowing from the Photocircuits site onto the Pall Site into shallow and intermediate groundwater. The Department asserted at that time that the hydraulic controls at the Photocircuits' site were adequate to prevent the flow of contaminated groundwater onto the Pall Site. It further indicated that if future data were to show otherwise, the Department would review its earlier conclusions regarding Photocircuits' controls.

Pall is in the process of preparing a Remedial Action Work Plan for OU-1 at the Site. Pall's most recent monitoring data confirm that the migration of contaminated groundwater from the Photocircuits site continues to occur. The data also confirm the presence of an artesian groundwater effect in the OU 1 off-site area (e.g., MW-1GC – MW-2GC clusters) that has moved contamination from the deep groundwater zone to the shallow and intermediate groundwater zones.

Before we finalize the draft Work Plan, we would like to meet with the Department to discuss this data and remedial action objectives for the Site in light of the ongoing migration of contamination onto the Site. In addition to the Department's project managers for the Pall and Photocircuits sites, Pall requests Chittibabu Vasudevan to attend the meeting. We also request the Department to arrange for one of its hydrogeologists to attend the meeting.
