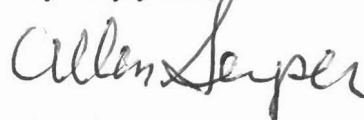

Dear Mr. Burke:

Groundwater samples were obtained for laboratory analysis from the on-site well M-3 and the three off-site wells (M-4, M-5, and M-6). The results are presented in Table 1. Figure 1 shows the location of the monitoring wells.

The results of groundwater analysis (Table 1) show a large increase in c-1,2 Dichloroethene in the on-site groundwater well M-3. In April 2002, the value for c-1,2 Dichloroethene was 360 µg/L (Table 2). Current test result levels for this breakdown product are 5,600 µg/L. I attribute this to the migration of contaminants from the former drywells due to the operation of the air sparging system. The off-site wells (MW-4, MW-5, and MW-6) are only minimally contaminated. It is anticipated that, with time, the contamination in MW-3 will decrease significantly.

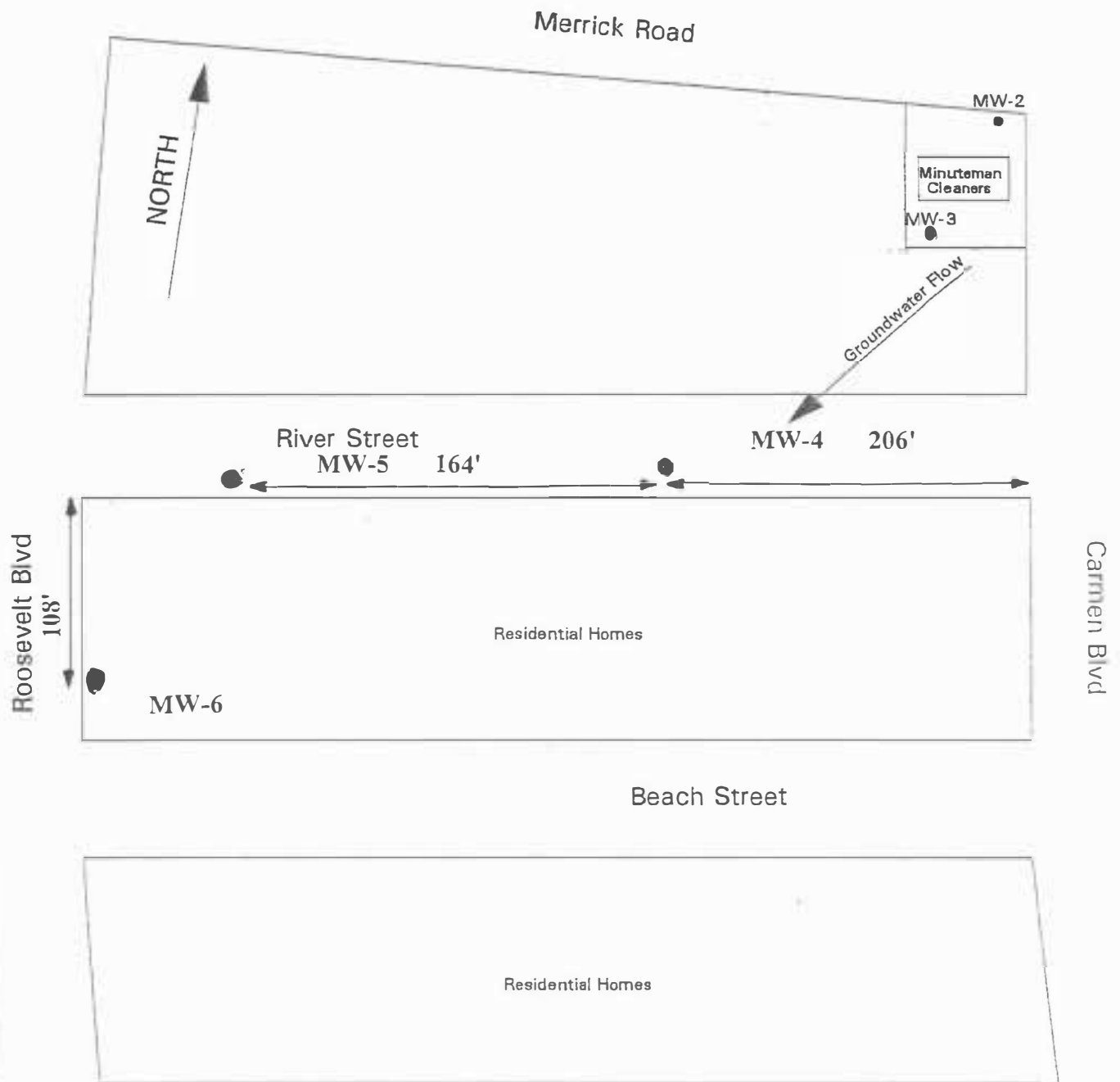

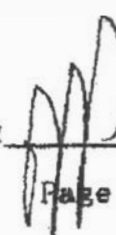
