1. 65 Daly Road LLC, a limited liability company organized and existing under the laws of the State of New York, is the current owner of property located at 65 Daly Road, East Northport, Suffolk County, New York (the "Property"), which includes the Deutsch Relays, Site No. 152003 (the "Site"). Exhibit "A" is a map of the Property showing its general location.
2. The New York State Department of Environmental Conservation (the "Department") and The Engel Burman Group LLC and Engel Burman Daly Road LLC executed an Order on Consent, Index # CO 3-20181123-203, dated April 25, 2019 with respect to the Property (the "Order"). A copy of the Order is attached as Exhibit "B".
3. By electronic mail dated May 3, 2019, The Engel Burman Group LLC and Engel Burman Daly Road LLC through its' attorney, Mr. Barry Cohen, Esq. notified the Department pursuant to Paragraph IX (F) of the main body of the Order "that the closing of the purchase of the Property was completed on May 1, 2019" and further advised the Department that "on the same day, Respondent Engel Burman Daly Road LLC assigned its contractual right to purchase the Property to 65 Daly Road LLC and that, as a result, 65 Daly Road LLC is the new owner of the Property".
4. The Department and The Engel Burman Group LLC and Engel Burman Daly Road LLC agree that a modification of the Order is warranted.
5. Subparagraph XVI.E.1 of Appendix A - "Standard Clauses for All New York State, State Superfund Orders" of the Order provides for modifications to be made in writing and subscribed by the party to be bound. Subparagraph VI.A.1 of the main body of the Order provides the designation of Richard P. Mustico to receive communication from the Respondent.

**NOW**, having considered this matter and being duly advised, **IT IS ORDERED THAT:**

I. Whereas Paragraph 2.A of the Order is hereby modified to read as follows:

The Engel Burman Group, LLC, a foreign corporation not currently registered to do business in New York State pursuant to New York State Business Corporation Law, entered into an agreement to purchase an approximately 14.3 acres property located at 65 Daly Road, East Northport, Suffolk County, New York (the "Property"), and subsequently assigned its purchase rights to Engel Burman Daly Road LLC, a New York State limited liability company. Engel Burman Group, LLC hereby waives its rights, if any, to contest the Department's jurisdiction to issue and hereafter to enforce this Order or otherwise act in furtherance of this Order. Additionally, Engel Burman Group, LLC hereby appoints Craig Masheb, Esq. (Engel Burman Daly Road LLC, 67 Clinton Road Garden City, NY 11530) as its agent for service of process by the State of New York. 65 Daly Road LLC is the current owner of the Property. 65 Daly Road LLC, The Engel Burman Group LLC and Engel Burman Daly Road LLC are collectively referred to as the "Settling Respondent". The Property is identified on the Suffolk County Tax Map as District 0400, Section 215, Block 02 .00, Lot 055.0001 at the approximate locations shown on a map attached to this Order as Exhibit "A" and being more particularly described in Appendix "A-1" attached hereto and made a part hereof.

II. VI.A.1 of the main body of the Order is hereby modified to read as follows:


