State Superfund Site Reclassification Notice Class 02 to Class 04

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- The Site Management Plan includes Institutional Controls necessary to address residual contamination that remains on-site and will provide proper management of the site to ensure the protection of public health.
- Institutional Controls in the form of an Environmental Easement have been placed on the property to control future site use, including a restriction on the use of groundwater without treatment, and prohibit activities at the site that will disturb remaining contaminated material unless conducted in accordance with the Site Management Plan.
- The potential for vapor intrusion must be evaluated for any buildings developed within the Institutional Control boundaries and appropriate actions must be implemented to address possible exposure.
