Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (Department) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (the "Registry"). The site identified above, and located on a map on the reverse side of this page, was recently added to the Registry as a (Class2 – Significant threat to the public health or environment – action required) site that presents a significant threat to public health and/or the environment for the following reason(s):

The Old Sump Site had been delisted prior to filling in the basin. The results of the sampling data following the fill-in project indicated the need for the Fairchild Old Sump Site (Old Recharge Basin) to be re-listed as a Class 2 site due to failure of the remedy to adequately address the significant threat. Re-listing as a Class 2 will facilitate implementation of an environmental easement/deed restriction (including a soils management plan) and allow a reevaluation of remedy selection for the former recharge basin. The Department will keep you informed throughout the investigation and cleanup of the site.

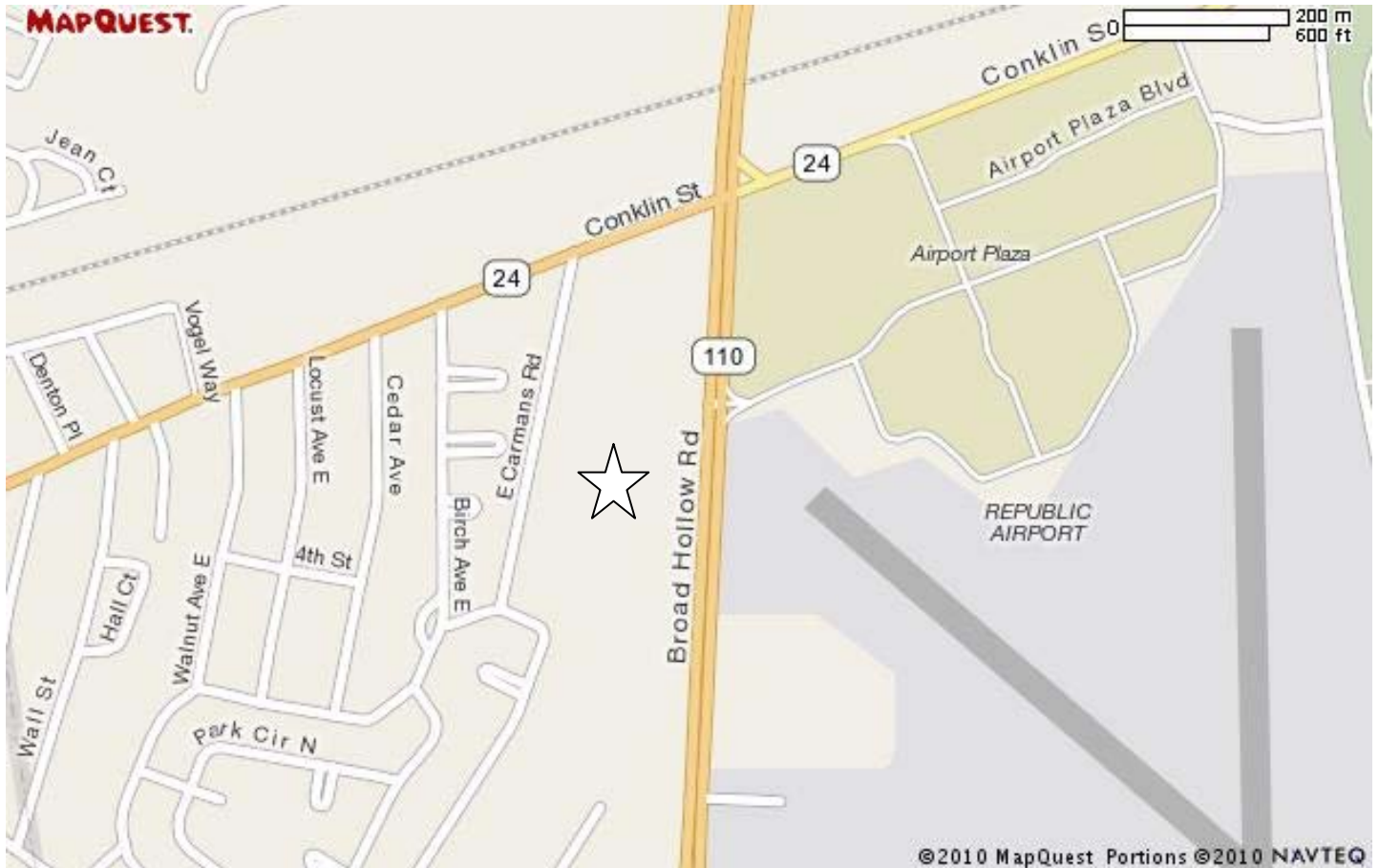
