## PROJECT FACT SHEET

### Remedial Investigation Target Rock Site East Farmingdale, New York March 2009

---

***Work will be going on at the Target Rock Site and the New York State Department of Environmental Conservation wants you to know that...***

Remedial Investigation (RI) activities associated with the Target Rock Site are scheduled to start in March 2009. The RI activities will be performed by ARCADIS of Melville, New York, on behalf of Curtiss-Wright Flow Control Corporation, Target Rock Division.

This work will be conducted according to plans that have been approved by the New York State Department of Environmental Conservation (NYSDEC). All work will be performed under the oversight of, and in accordance with methods approved by, the NYSDEC. Following the completion of the RI, an RI Report will be prepared and will be available at the Farmingdale Public Library.

**WHAT ACTIVITIES ARE BEING DONE?** ARCADIS will be drilling and sampling temporary monitoring wells, sampling permanent monitoring wells, drilling and sampling soil borings, and drilling and sampling soil vapor points at locations on the Target Rock Site property.

**HOW LONG WILL THIS WORK TAKE?** The RI activities are scheduled to start in March 2009 and are expected to be completed by the spring of 2009; however, the work at a particular sampling location will be of a much shorter duration.

**WHAT SCHEDULE WILL BE FOLLOWED?** The activities will take place Monday to Friday between the hours of 7 a.m. and 5 p.m. The work day may be extended beyond 5 p.m. as necessary to complete activities, but will be limited to the extent reasonably possible.

**WHAT TYPE OF EQUIPMENT WILL BE USED?** Equipment used will include trucks, drilling rig, portable water containers, and sampling equipment. The drilling rig will remain at the location until its work is complete. Soil, water, and incidental waste generated from the work will be staged at an appropriate area on the Target Rock Site property. The work is being conducted by trained personnel in accordance with an approved Health and Safety Plan (HASP). The HASP can be found within the approved Work Plan, on file at the Site repository (Farmingdale Public Library, located on Merritts Road in Farmingdale).

**WHAT WILL WE DO TO ENSURE THE WORK SITE IS SECURE AND SAFE?** Air quality will be monitored continuously during investigation activities and dust suppression methods will be used, as necessary. The work will be performed within the secure Target Rock Site property.

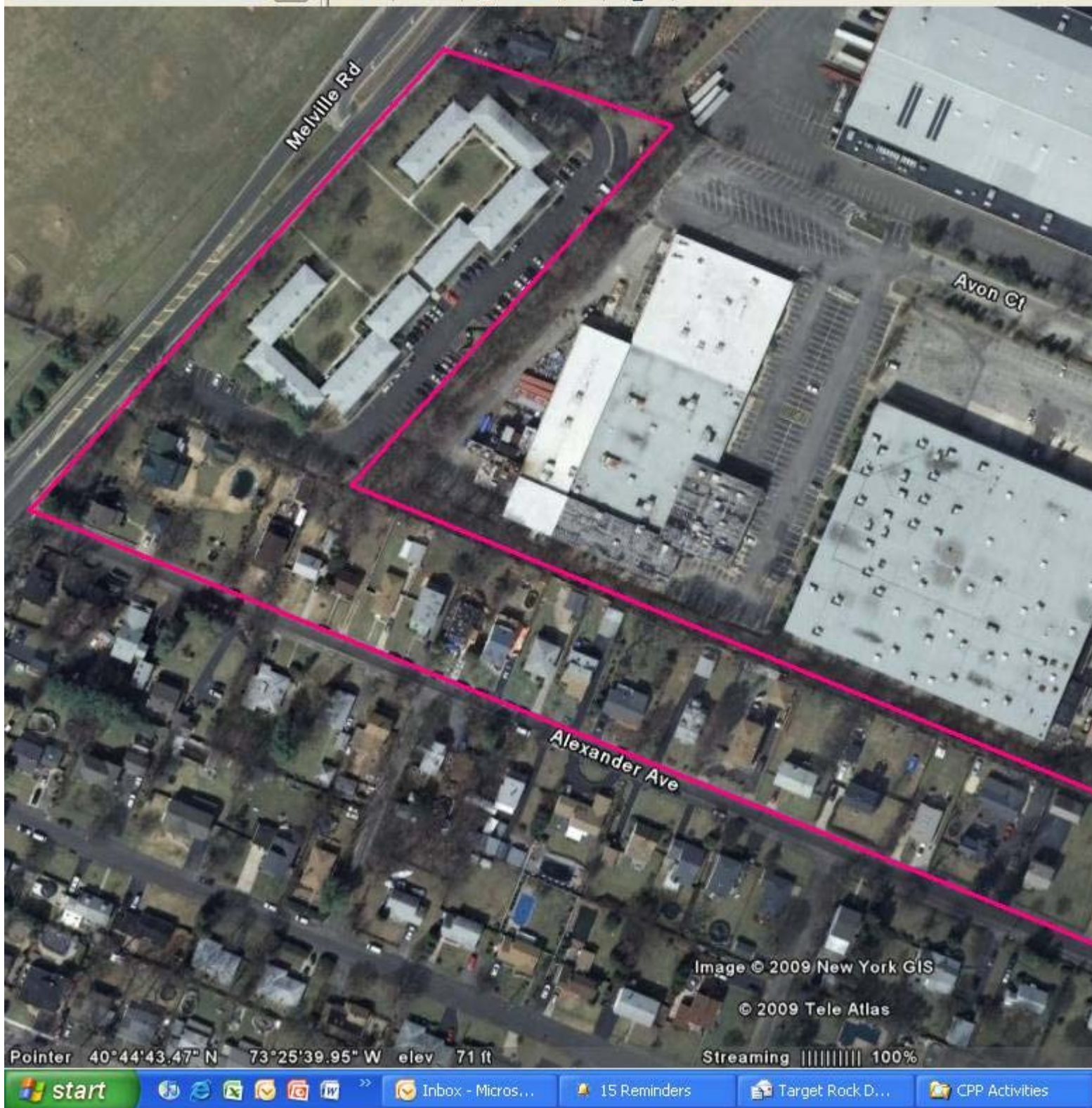
