State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

- On-site soil, groundwater and soil vapor are contaminated with chlorinated volatile organic compounds above relevant Standards, Criteria and Guidance. Additional investigation is needed to: define the nature and extent of site-related contamination; characterize potential human exposure pathways both on and off the property; and evaluate remedial alternatives to address potential exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.


