Scope of Work:

- PFAS analysis for the standard list of six PFAAs, including PFOA and PFOS via Test America's method certified compliant with ISO 25101.
- Metals analysis, including arsenic and lead, via EPA method 200.8.
- TOC analysis via standard method 5310 B.

Analytical data shall be submitted in the following format:

- Electronic data deliverables (EDD) –NYSDEC EQulS and Excel Formats;
- NYSDEC ASP Category B data package; and
- A bookmarked searchable PDF of the data summary report.

Analytical results are provided with non-detects reported at the reporting limit.

Test America shall provide daily courier service to the Hoosick project site (Baby Lane) for pickup of samples and dropoff of certified clean bottleware, and provides all labor, supplies, and shipping fees associated with preparing and shipping samples to designated laboratories for analysis.

Bottle Orders/analysis shall be closely coordinated with Arcadis staff.
