State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

- The site was evaluated to determine if the presence of perfluorooctane sulfonic acid (PFOS) and perfluorooctanoic acid (PFOA) in groundwater samples obtained near the site was the result of potential use and/or testing of aqueous film forming foam at the station.
- The evaluation to date of public and private drinking water wells in the area has not indicated that the site is the cause of detections of PFOA/PFOS in the water; however, it cannot be ruled out. This is a sole source aquifer and evaluation of potential sources of contamination in the aquifer should be addressed.
- Additional investigation is needed to define the nature and extent of site-related contamination; to evaluate
 associated human exposure pathways; and, to determine the appropriate actions to prevent and/or mitigate
 potential exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.

Health Assessment

The site is partially covered by asphalt or concrete, which restricts access to soil. However, persons who enter the site could contact contaminants in the exposed soil by walking on the site, digging or otherwise disturbing the soil. The area is primarily served by a public water supply, with a limited number of private wells in the vicinity of the site. The evaluation to date of public and private drinking water wells in the area has not indicated that the site is the cause of detections of PFOA and PFOS in the water; however, it cannot be ruled out, and additional site investigations are needed so that all site related exposure pathways are identified. In addition, any water wells that exceed drinking water standards have had treatment installed on them to eliminate potential exposures to contamination, regardless of the source.
