#### Environmental Cleanup to Begin at State Superfund Site

Action is about to begin that will address contamination related to the 1120 Westchester Avenue Site ("site") located at 1120 Westchester Avenue, Bronx, under New York State's Inactive Hazardous Waste Site Program. The cleanup activities will be performed by West Levy LLC ("Remedial Party") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). The Interim Remedial Measures Work Plan ("IRM Work Plan") has been found by the NYSDEC to be protective of public health and the environment and has been approved by NYSDEC. The approved IRM Work Plan and other documents related to the cleanup of this site can be found at the document repositories listed in the box at left. Remedial activities are expected to commence in September 2017, and are expected to last approximately 2 weeks.

<u>Highlights of the Upcoming Cleanup Activities</u>: The goal of the cleanup action for the Site is to achieve cleanup levels that protect public health and the environment. The key components of the IRM are:

- Installation and operation of a Soil Vapor Extraction (SVE) system to remediate impacted soil, control vapor intrusion into the on-site building, and address offsite soil vapor migration;
- Collection and analysis of soil samples to further delineate the area of on-site contamination;
- Collection and analysis of indoor air samples in the on-site building to confirm the effectiveness of the vapor mitigation;
- Collection and analysis of sub-slab soil vapor and indoor air samples in the adjacent buildings to evaluate the potential for vapor intrusion

A site-specific health and safety plan (HASP) and a Community Air Monitoring Plan (CAMP) will be implemented during remediation activities. The HASP and CAMP establish procedures for the protection of on-Site workers and residents and includes required air monitoring as well as dust and odor suppression measures.

<u>Next Steps:</u> After the Remedial Party completes the cleanup activities, they will prepare a Construction Completion Report (CCR) and submit it to NYSDEC. The CCR will document the cleanup activities completed under the IRM.

**Site Description:** The site is located at 1120 Westchester Avenue, Bronx, New York and the site is identified as block 2750 and lot 11. Records indicated that the subject building was built in approximately 1922. The building is a two story brick structure with a one residential apartment on the second floor. The first floor is currently vacant but was previously occupied by a dry cleaner. The building occupies the entire lot. A Site Location Map is attached.

The primary contaminants of concern at the Site are chlorinated volatile organic compounds, specifically tetrachloroethylene and its breakdown products, which are present site-wide in soil and soil vapor. 


Figure 1 – Site Location
