## **Public Meeting Scheduled for Proposed Remedy at MGP Site: Public Comment Period Announced**

The public is invited to comment on a no further action remedy being proposed by the New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH) related to the operable unit 1 (OU1) of the Dangman Park MGP site ("site") located at 486 Neptune Avenue, Brooklyn, NY. Please see the map for the site location.

How to Comment: NYSDEC is accepting written comments about the proposed plan, called a Proposed Remedial Action Plan (PRAP) from September 30, to October 30, 2021.

Based on the results of the site investigation and the two interim remedial measures (IRMs) implemented in 2017, NYSDEC is proposing no further action with a site cover, institutional controls, and site management as the site remedy. An expedited cleanup, called an IRM, is conducted at a site when a source of contamination or an exposure pathway can be effectively addressed before the final remedy is selected. The following IRMs were conducted at OU1 as follows:

• The first IRM consisted of targeted soil removal across the site to address shallow contamination. Excavation was completed in several areas to depths of approximately fifteen feet below ground surface. Approximately 1,300 cubic yards of contaminated soil was removed from these areas and sent to an off-site permitted disposal facility.

• The second IRM consisted of injecting gypsum into the subsurface to treat coal tar and petroleum contamination by means of anaerobic oxidation. The gypsum stimulates the existing bacteria to accelerate the degradation of the contaminants. Approximately 59,000 pounds of gypsum was injected at 58 locations over an area of approximately 15,000 square feet.

As noted above, in addition to these IRMs that addressed the contamination found at the site, NYSDEC is proposing a site cover, an environmental easement and site management plan to be put in place to allow the site to be used for restricted residential, commercial, or industrial use, as permitted by local zoning.

NYSDEC developed the proposed remedy after reviewing the detailed investigation of the site and evaluating the remedial options in the "feasibility study" submitted under New York's State MGP Program by National Grid ("responsible party").

**Next Steps:** NYSDEC will consider public comments as it finalizes the site remedy. The selected remedy will be described in a document called a "Record of Decision" that will explain why the remedy was selected and respond to public comments.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

**Site Description:** The Dangman Park MGP site is located in an urban area, in Coney Island, Brooklyn. The site comprises approximately 1 acre of land bounded by Neptune Avenue to the north, W. 5th Street to the east, a residential parcel to the south, and a commercial parcel to the west. The site is contained within lots 1R and 25 of Block 7273, with a large portion of lot 1R designated as "Operable Unit No. 1" (OU1), and a portion of the parking area on lot 25 designated as "Operable Unit No. 2" (OU2).

A large portion of the former shopping center was demolished which allowed for the IRMs to be performed on OU1 concurrent with redevelopment. A portion of the former shopping center structure still exists to the west of the site but is vacant. A one-story commercial structure was recently constructed on the majority of OU1 which houses various businesses including a bank, a bagel shop, and a drug store.

OU2 will be the subject of a future Proposed Remedial Action Plan and Record of Decision.

**Summary of the Investigation:** Based upon investigations conducted to date, the primary contaminant of concern is MGP-related coal tar and associated compounds including benzene, toluene, ethylbenzene, xylenes (BTEX) and polycyclic aromatic hydrocarbons (PAHs). These contaminants were observed in the soil and groundwater at the site, primarily in the area of the former MGP operations.

MGP Program Overview: New York's MGP Program oversees the investigation and cleanup of former MGP sites. These sites undergo a process of investigation, evaluation, cleanup, and long-term monitoring.

The gas manufacturing process involved the heating of coal and/or petroleum products to produce a gas mixture. Once cooled and purified, the gas was distributed through a local pipeline network. The gas was used for heating and cooking much like natural gas is used today. In the early years, the gas was also used for lighting in homes and streetlights.
