This Weekly Air Monitoring Report summarizes perimeter air monitoring data collected during the referenced period in accordance with the Community Air Monitoring Plan (CAMP) which was included as part of the NYSDEC approved Remedial Action Work Plan for the Former Fulton Manufactured Gas Plant (MGP) Site – Parcel III and Portion of Parcel IV.

CAMP Monitoring Approach

Air monitoring was performed during the reporting period in accordance with the CAMP. Air Monitoring location for the reporting period is shown on **Figure 1.** The air monitoring program consists of:

- Continuous monitoring for total volatile organic compounds (TVOCs) and airborne particulate dust (PM₁₀) concentrations at the five air monitoring stations (AMS-1 through AMS-5).
- Compound-specific monitoring for benzene and tri-chloroethylene (TCE) if the TVOC concentration is greater than the alert level (i.e., 3.75 ppm above background) at the station.
- Continuous monitoring of weather conditions.
- Periodic monitoring for TVOCs and PM₁₀ along Degraw Street using handheld equipment.
- Periodic observational monitoring for MGP-related odors and visible dust around the perimeter of the Site.

Action and Alert levels for monitored parameters are included in **Table 1**.

Air Monitoring Summary

During the reporting period, GZA collected air monitoring data consisting of TVOC and PM₁₀ concentrations with the five air monitoring stations and using handheld instruments along Degraw Street. GZA also conducted observational monitoring for MGP-related odors and visible dust around the perimeter of the Site.

There were no TVOCs or PM_{10} concentrations above the CAMP-established action levels during the reporting period. Figures 2 and 3 summarize the TVOC and PM_{10} concentrations, respectively, recorded during the reporting period.

There were no observations of dust or odors associated with the Site during the reporting period. **Table 2** summarizes the observational monitoring for MGP-related dust and odors during the reporting period.

There were no community inquiries received during the reporting period.



Figure 1 – CAMP Station Locations





Figure 2 – Summary of TVOC, Benzene, and Tri-chloroethylene Concentrations 01/30/23 through 02/05/23






Former Fulton MGP Site Parcel III and Portion of Parcel IV Brooklyn, NY






Former Fulton MGP Site Parcel III and Portion of Parcel IV Brooklyn, NY






Former Fulton MGP Site Parcel III and Portion of Parcel IV Brooklyn, NY






Former Fulton MGP Site Parcel III and Portion of Parcel IV Brooklyn, NY






Former Fulton MGP Site Parcel III and Portion of Parcel IV Brooklyn, NY






