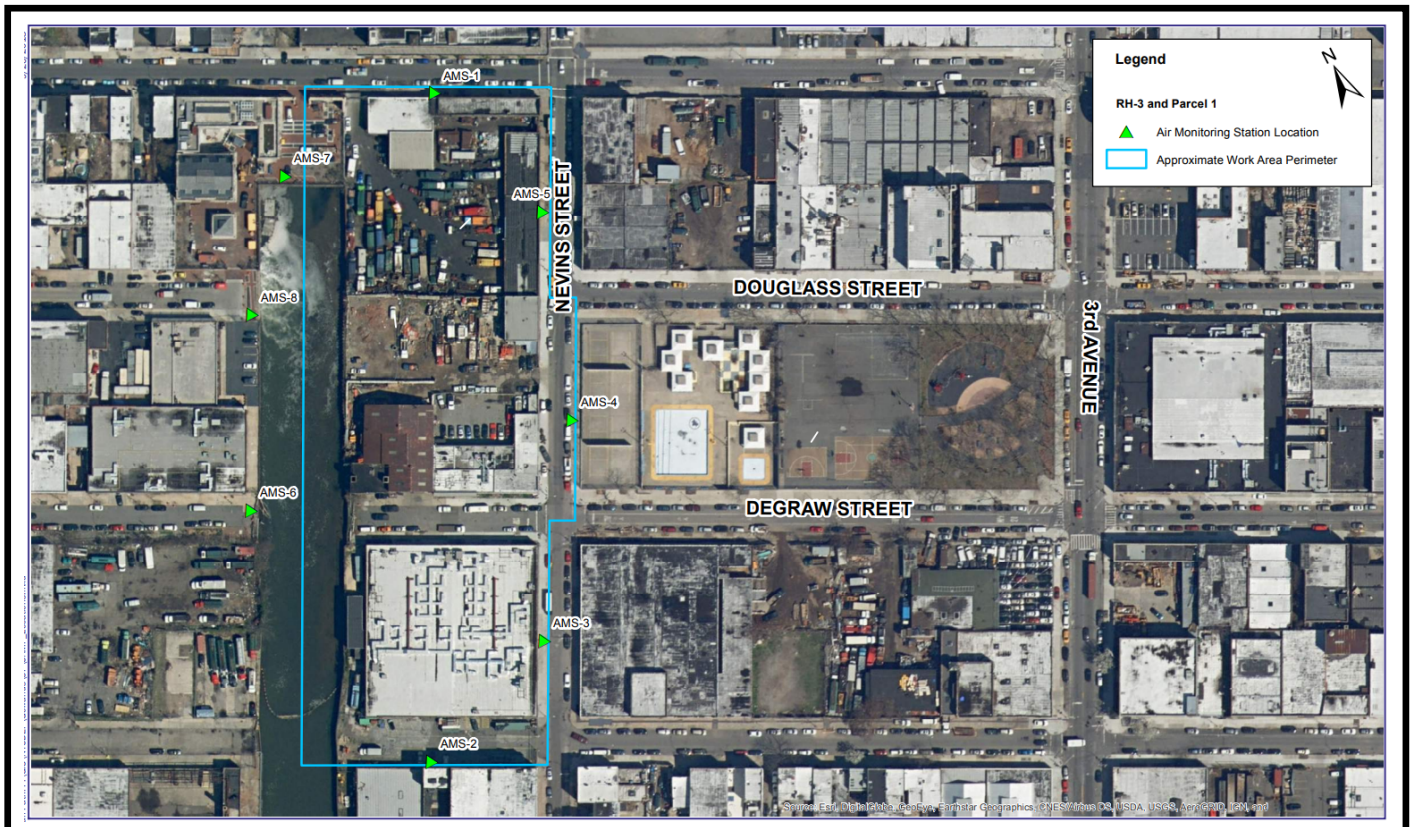


Date:

Figure 1 - CAMP Station Locations

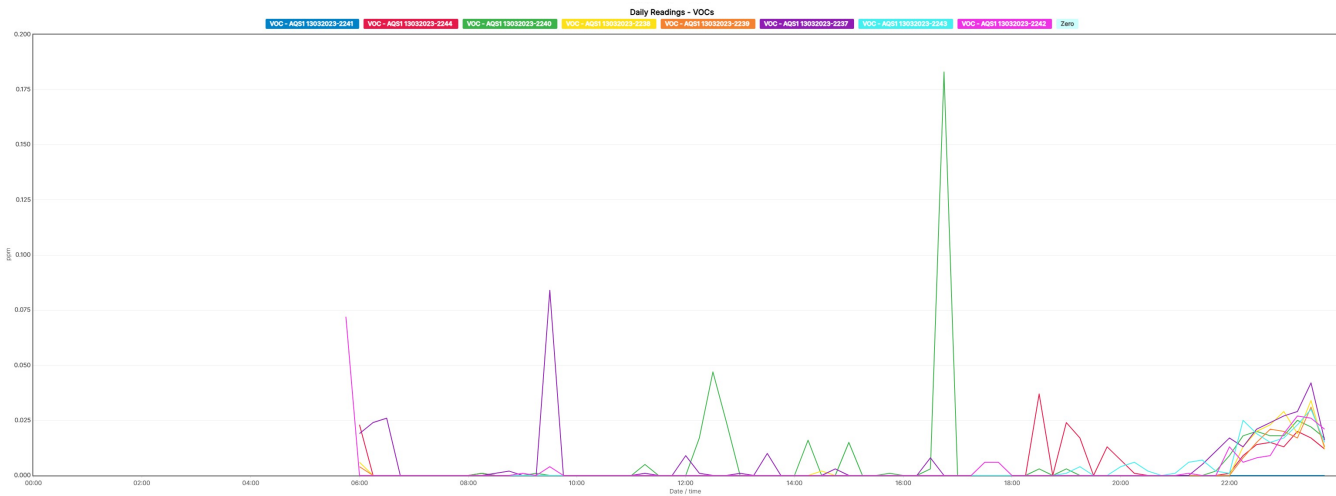

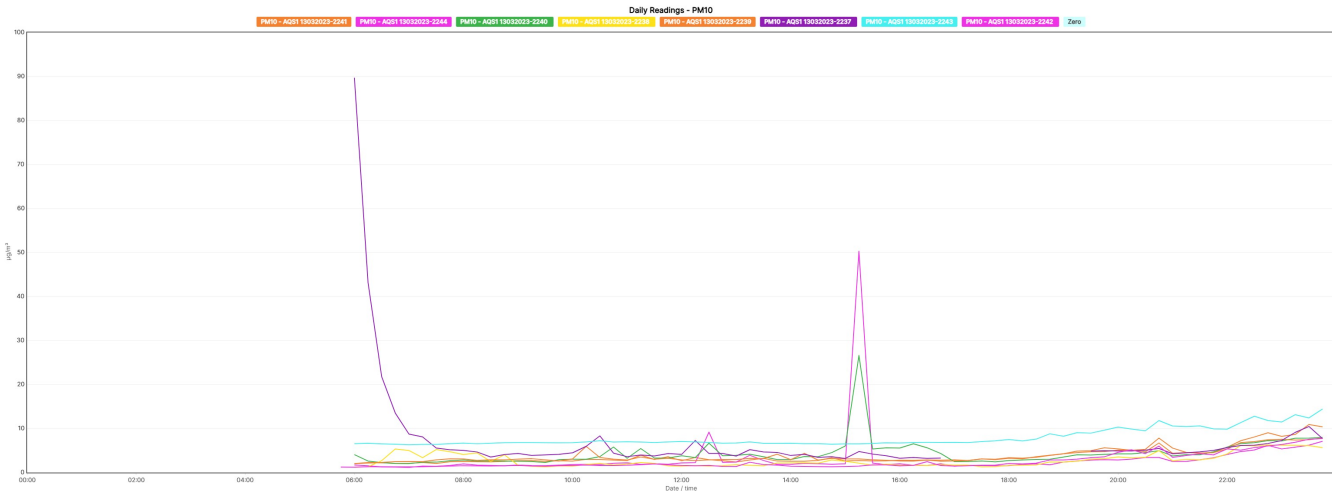
