

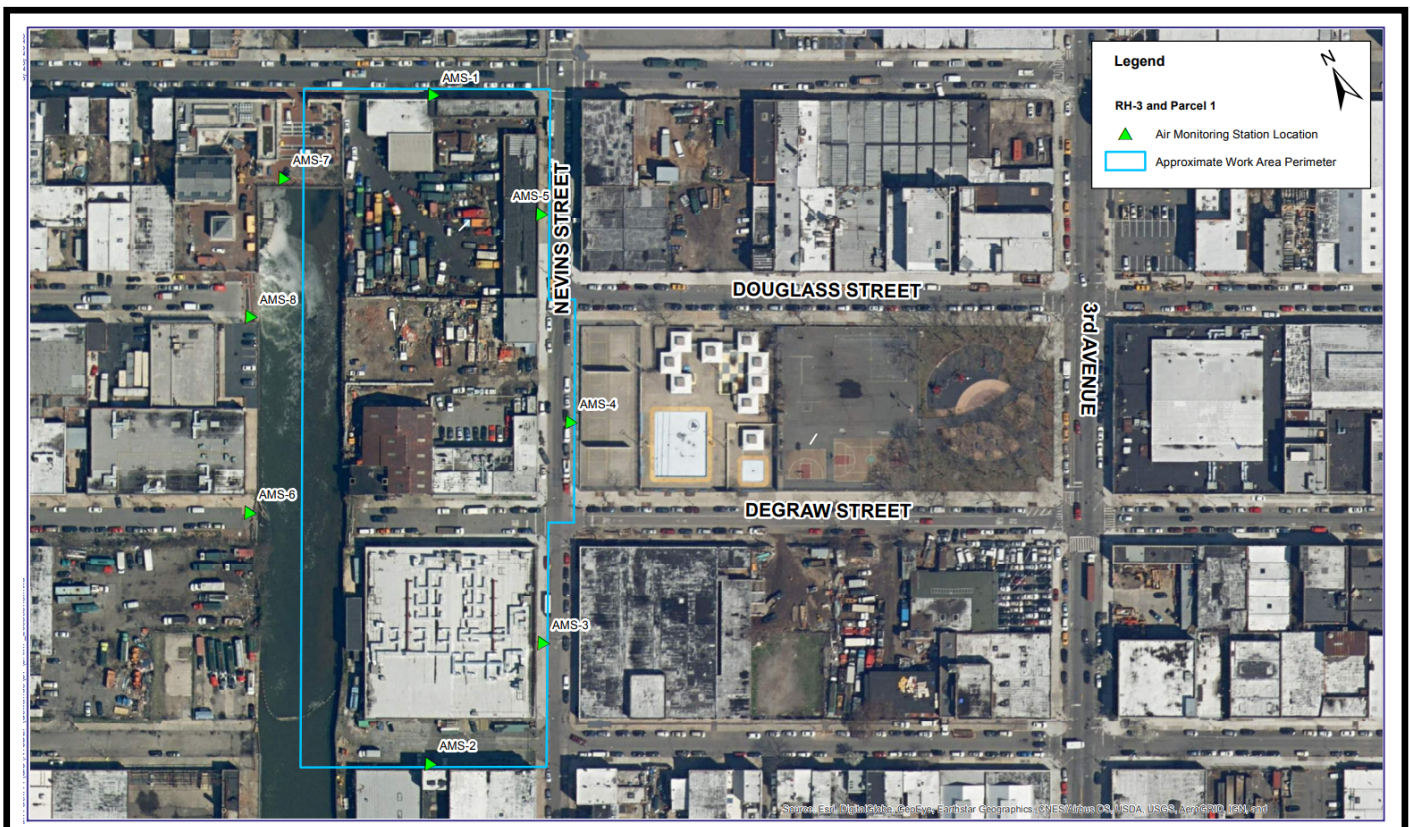
Gowanus CSO Tank - CP2 Daily CAMP Report

There was a PM10 spike observed at AMS-3 due to the influence of the odor control misting system operating in that area.

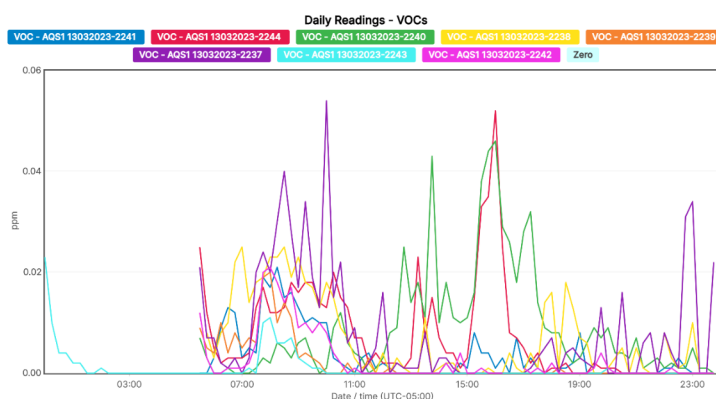

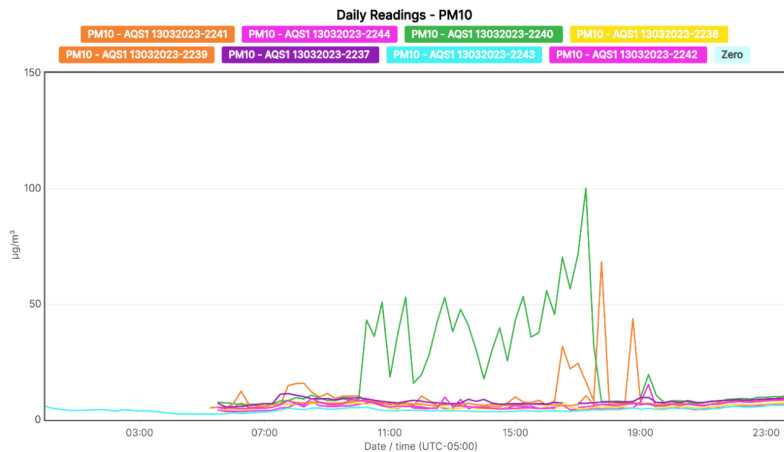
