

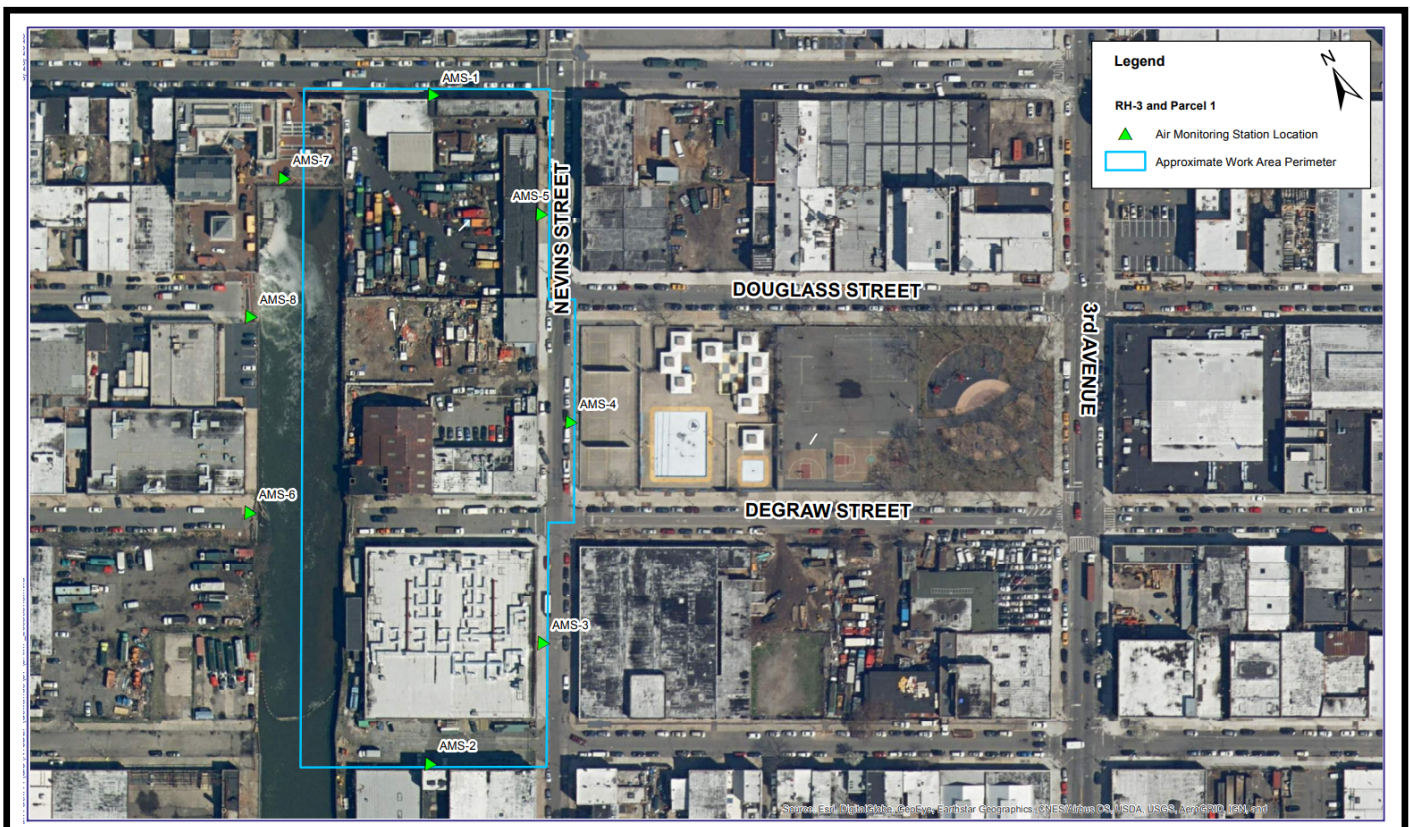
Gowanus CSO Tank - CP2 Daily CAMP Report

Figure 1 - CAMP Station Locations



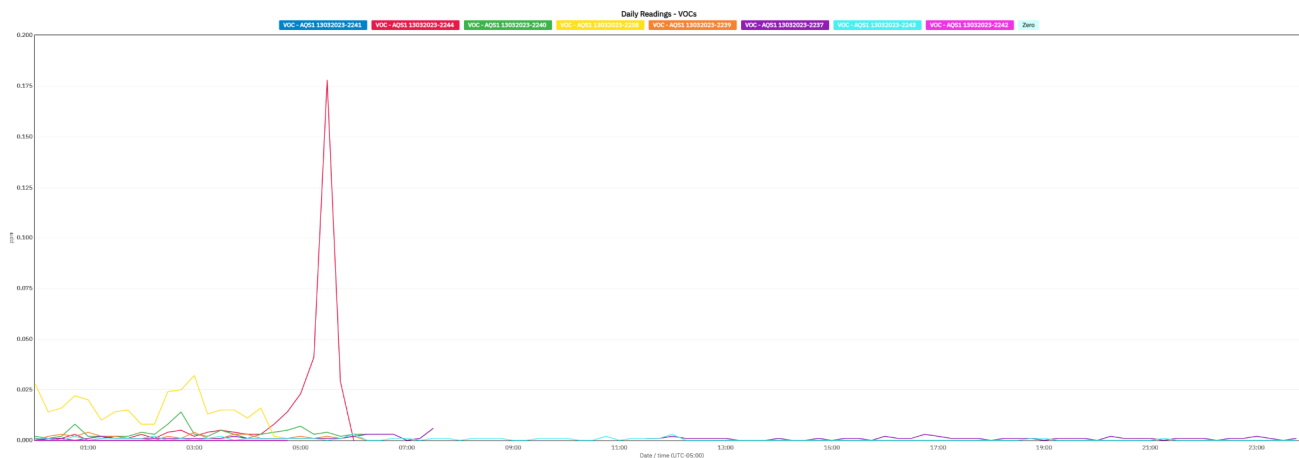

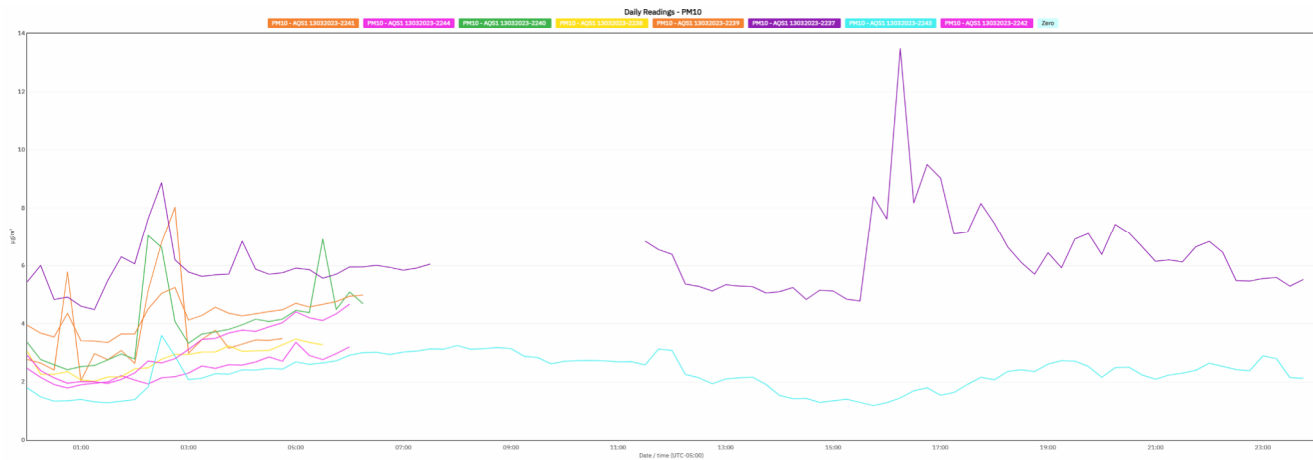
