

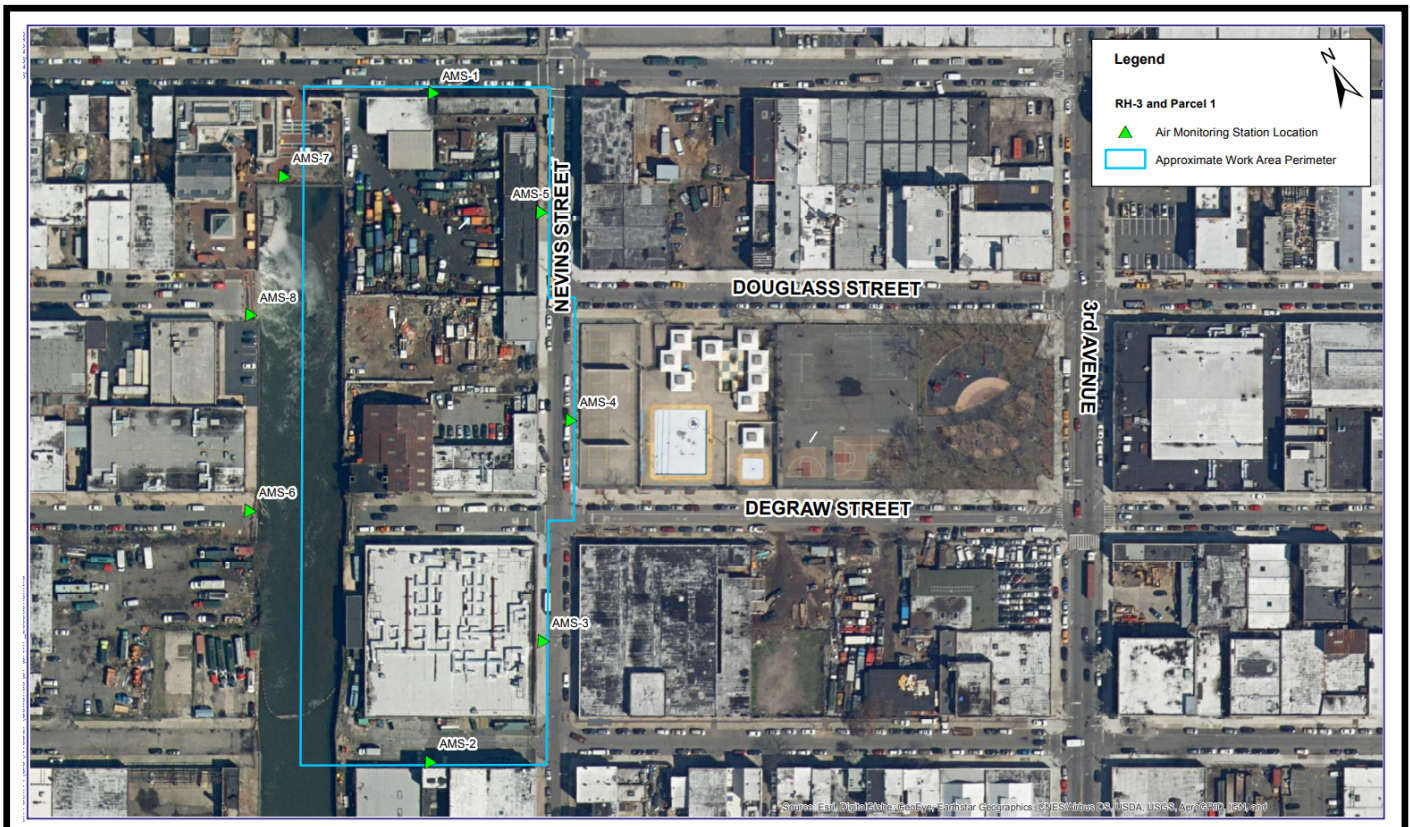
Gowanus CSO Tank - CP2 Daily CAMP Report
