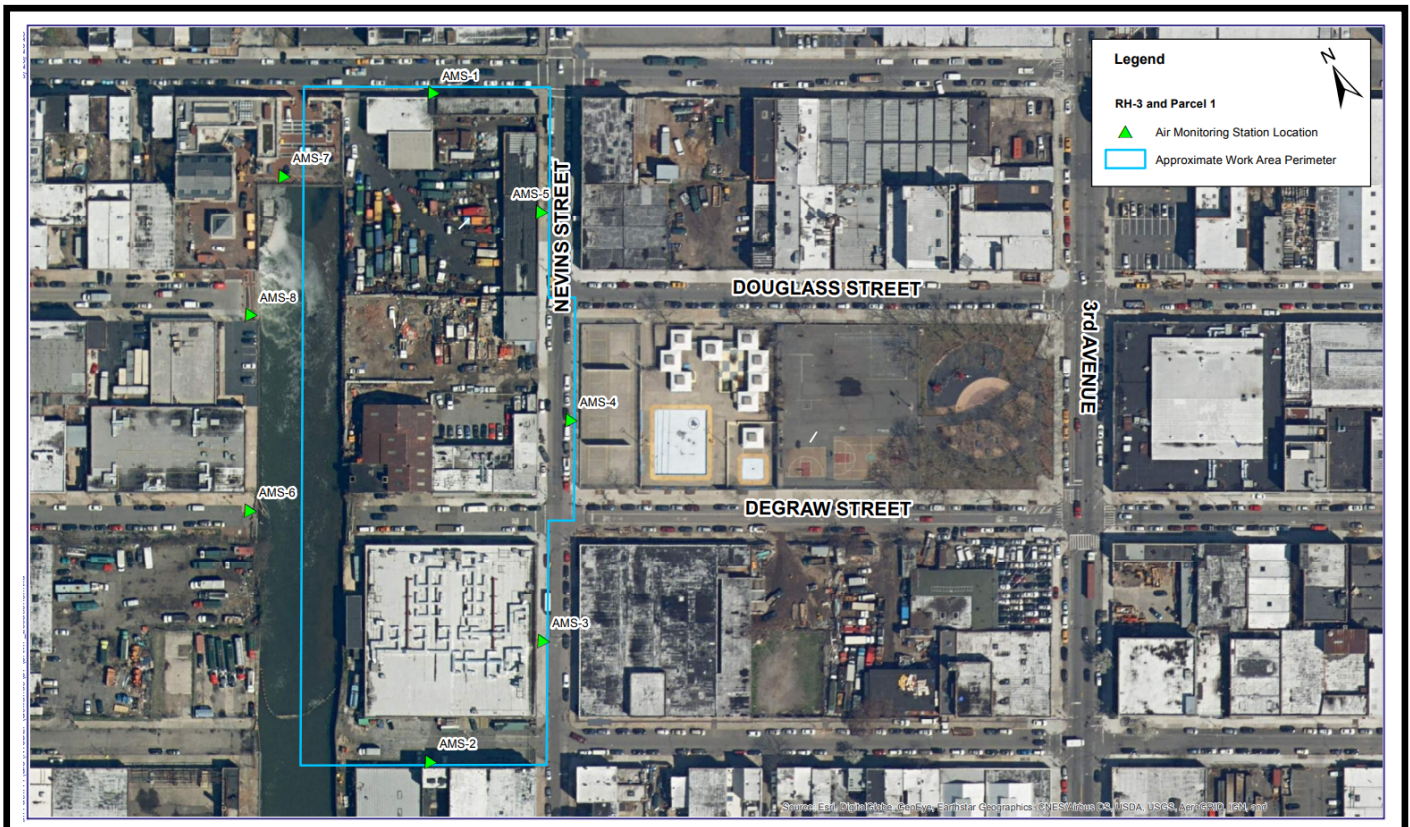


Date:

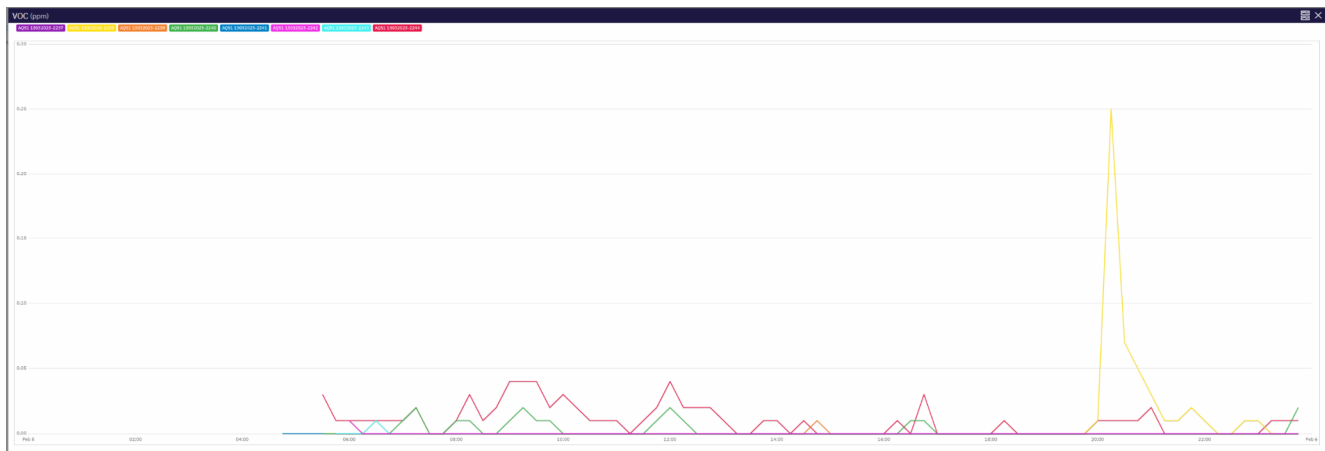

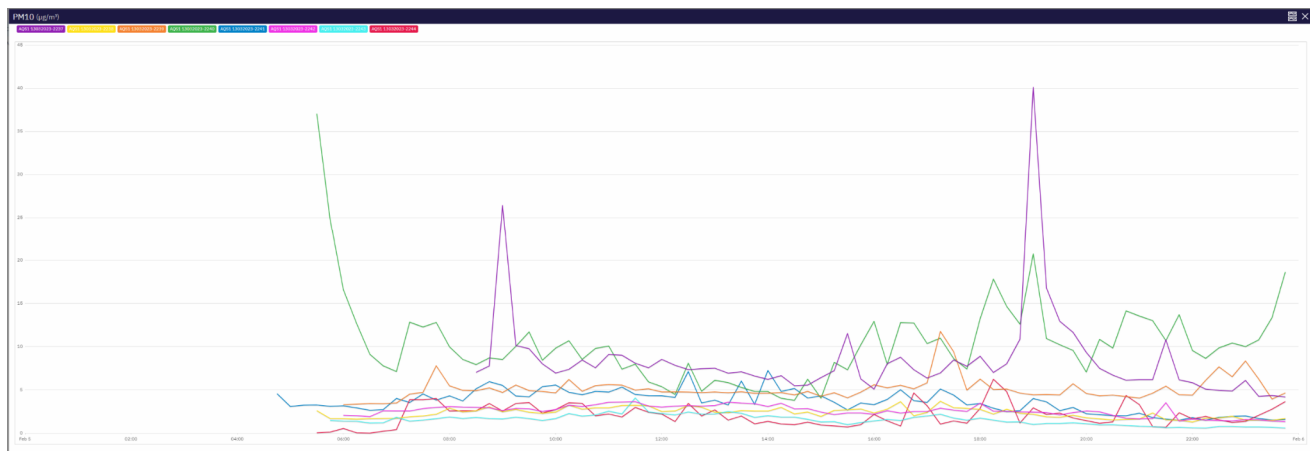
