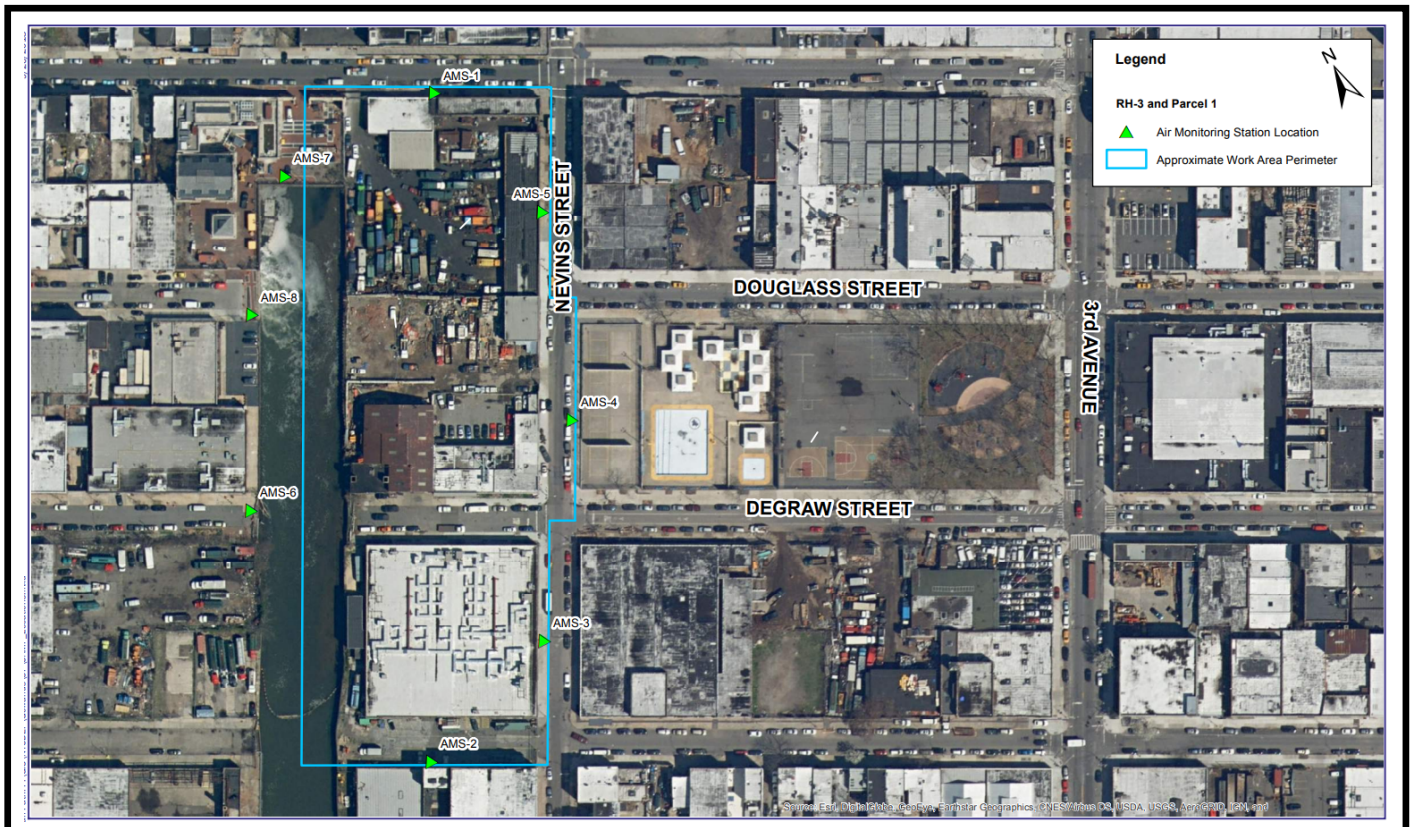


Date:

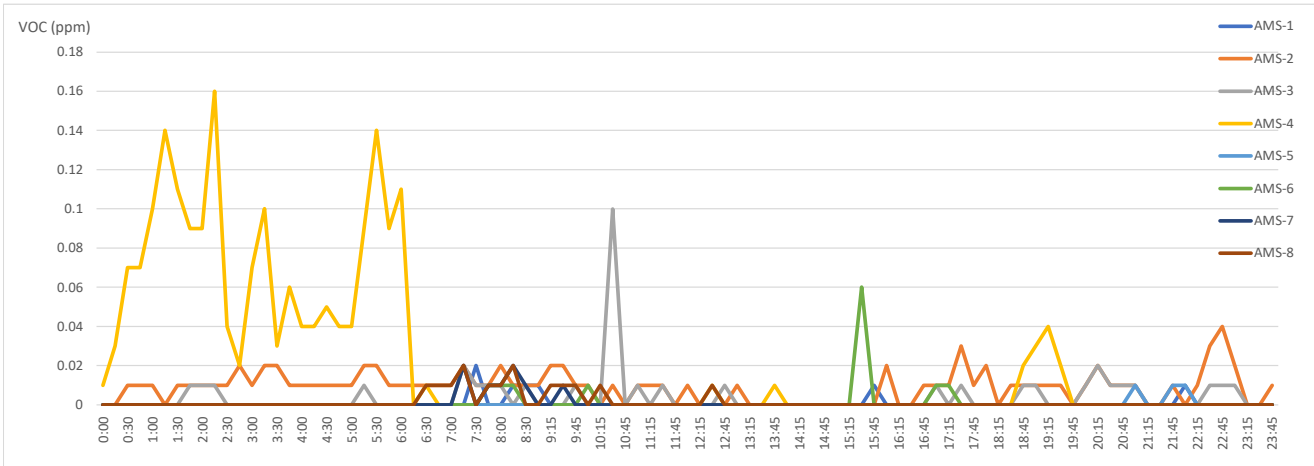

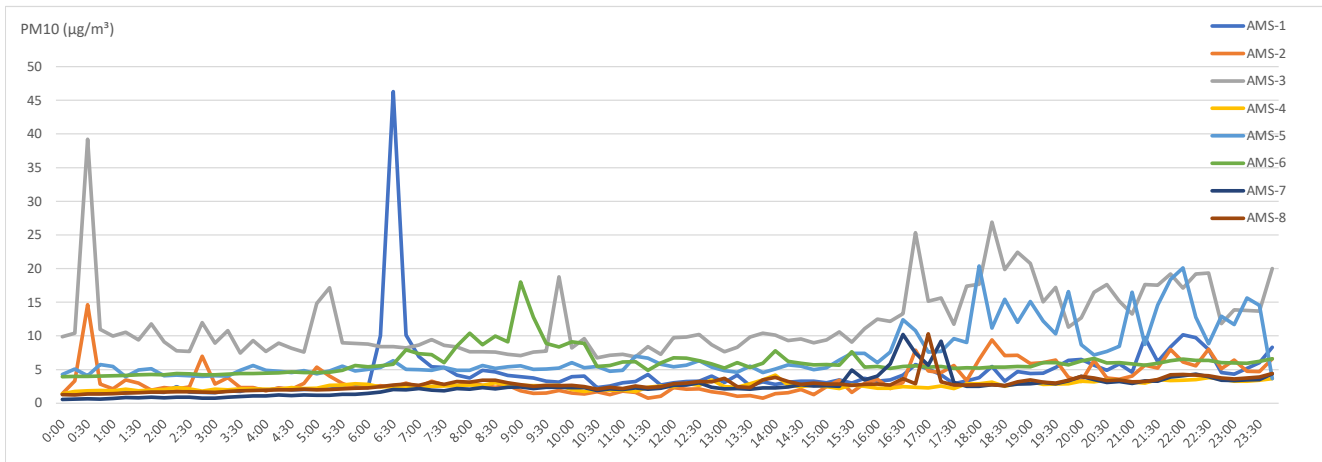
