### Remedial Action Work Summary

#### Work Activities Performed Onsite:

- Excavation and loadout of material from waste characterization grids WC-GHW (6-13) and WC-GHN (6-13) for offsite disposal at Chemical Waste Management (CMW) Emelle.
- Excavation and prep for future loadout of material from Gas Holder 3 excavation area.
- Continue dewatering operations for Gas Holder 3 excavation area.
- Bi-weekly sentinel well sampling event.

#### Contractor Work Performed Onsite:

Creamer Environmental Inc. (CEI) excavated material and loaded out 13 trucks of MGP impacted urban fill from waste characterization grids WC-GHW (6-13) and WC-GHN (6-13) for disposal at Chemical Waste Management (CMW) Emelle. CEI continued reducing in size concrete and brick sections from both the former Gas Holder 3 foundation and backfilled material found inside the gas holder foundation. This material was stabilized and staged for future loadout.

ECS Environmental Solutions (ECS) continued 24-hour operation of the dewatering system for the Gas Holder 3 excavation area. Since the last reporting period, CEI treated approximately 756,500 gallons of recovered construction wastewater through the water treatment system (WTS) and discharged the treated water to the New York City Department of Environmental Protection (NYCDEP) combined sewer system. CEI backwashed the organoclay units associated with the WTS.

The vapor management system (VMS) associated with the tension fabric structure (TFS) was operated throughout the day. Other dust and odor control measures (wetting, tarping, limiting vehicle speeds, covering trucks inside TFS, etc.) continued to be performed to ensure there were no impacts to the neighborhood. All truck tires were cleaned before leaving the Site, so that material was not tracked onto the surrounding streets. Exposed soils were covered with Atmos odor suppressing foam during the work and at the end of the day.

#### Air Monitoring:

- An after-hours exceedance for TVOCs was detected in the upwind CAMP station and reported to the NYSDEC.
- GZANY to provide a summary report of CAMP activities separately.

#### Erosion and Sediment Control:

- None.

#### Sampling Conducted:

- Groundwater samples were collected from sentinel wells SW-01S, SW-01D, SW-02S, SW-02D, SW-03S, SW-03D, and SW-05D to be analyzed for the following parameters:

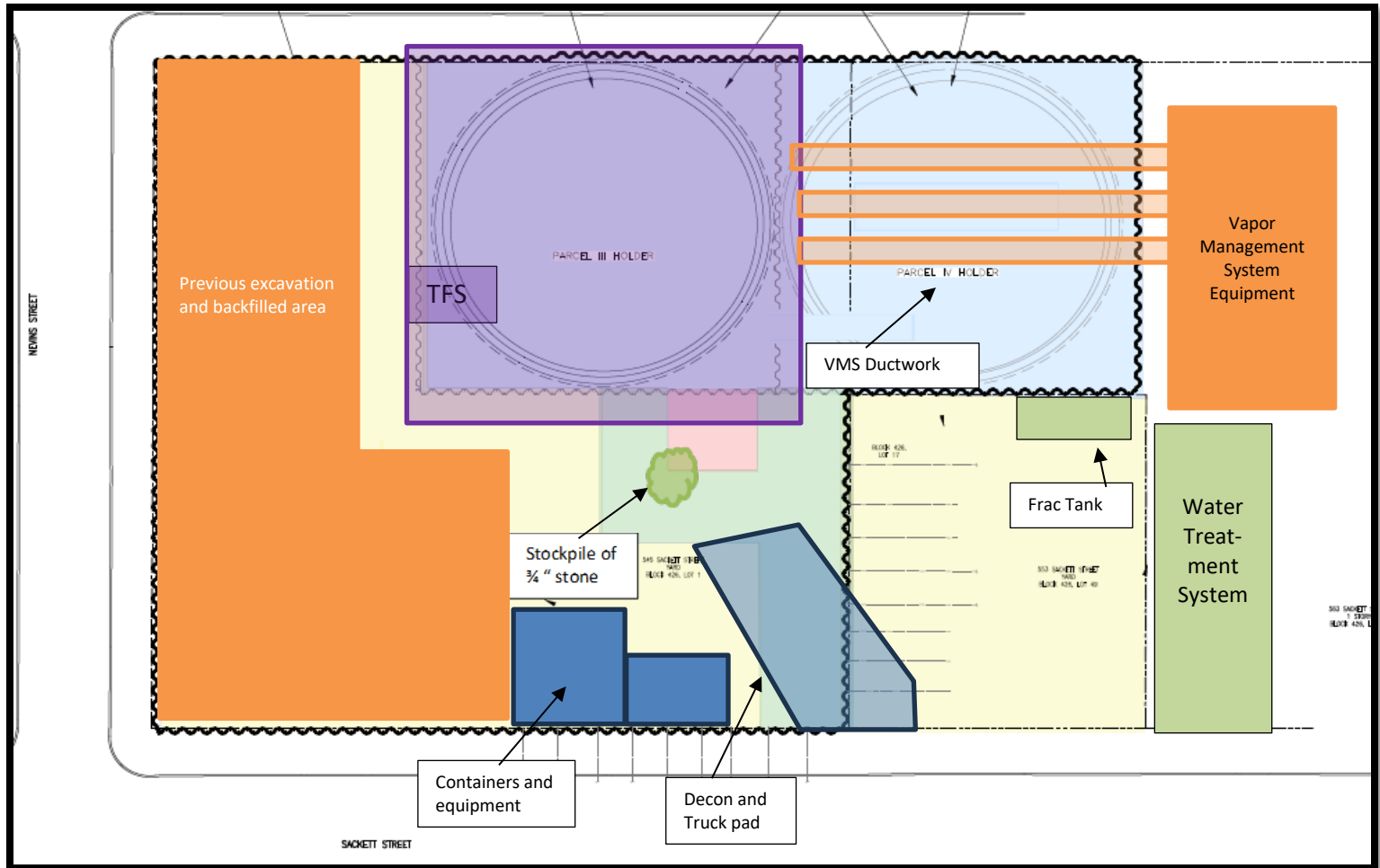

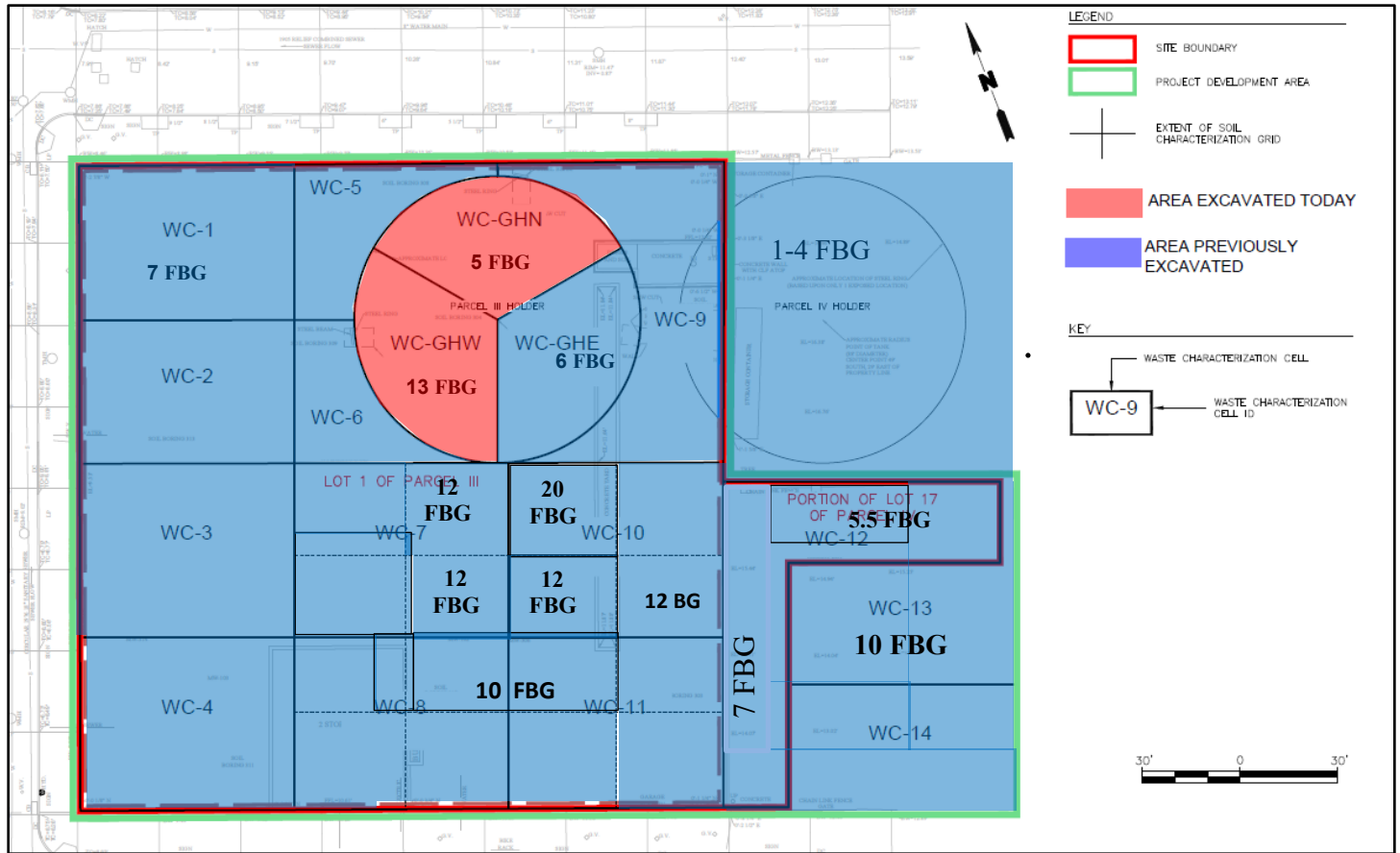
