### **Remedial Action Work Summary**

### Work Activities Performed Onsite:

- Excavation of material from the former Gas Holder 4 excavation area and loaded out for offsite disposal.
- Demolition of Gas Holder 4 wall.
- Preparation for support of excavation installation in Gas Holder 4 excavation area.

### **Contractor Work Performed Onsite:**

Creamer Environmetal, Inc (CEI) excavated material within former Gas Holder 4 and loaded out for offsite disposal. 21 triaxle trucks (approximately 420 tons) of nonhazardous MGP impacted material from waste characterization grids WC-15 (0-5 and 5-10), WC-GH4-1 (5-10) and WC-GH4-3 (0-5) were shipped to Clean Earth of New Castle. CEI also loaded 3 triaxle trucks (approximately 60 tons) of nonhazardous MGP impacted material from waste characterization grid WC-GH4-1 (5-10) to Clean Earth of Southeast Pennsylvania. CEI continued excavation and demolition of the Gas Holder 4 structure along the eastern portion of the site. All excavation work was performed within the tension fabric structure (TFS).

CEI continued preparation work to install support of excavation (SOE) in the Gas Holder 4 excavation area. CEI fabricated cofferdam bracing and chairs. CEI primed the newly installed water treatment system (WTS) vessels and Earth Construction Services (ECS) performed electrical work associated with the dewatering system in the former Gas Holder 4 excavation area.

The vapor management system (VMS) associated with the TFS was operated throughout the day. Other dust and odor control measures (applying Atmos odor suppressing foam, wetting, tarping, limiting vehicle speeds, covering trucks prior leaving the site, etc.) continued to be performed to ensure there were no impacts to the neighborhood. Truck tires were washed to ensure material was not being tracked offsite. Exposed soils were covered with Atmos odor suppressing foam during work operations.

### Air Monitoring:

- No VOC or dust exceedances were observed from the community air monitoring program (CAMP).
- GZANY to provide a summary report of CAMP activities separately.

### Vibration Monitoring:

- No alerts of vibrations exceeding Site's threshold or limiting criteria (1" /second and 2"/ second, respectively) were received.
- Vibration monitoring data is included at the end of this Daily Status Report.


- Continue demolition, excavation, loadout in former Gas Holder 4 excavation area.


