

Gowanus CSO Tank - CP2 Daily CAMP Report

AMS-1 is off-line awaiting repair due to a faulty sensor. A 5-gas meter will continue to be utilized at this location until AMS-1 can be brought online.

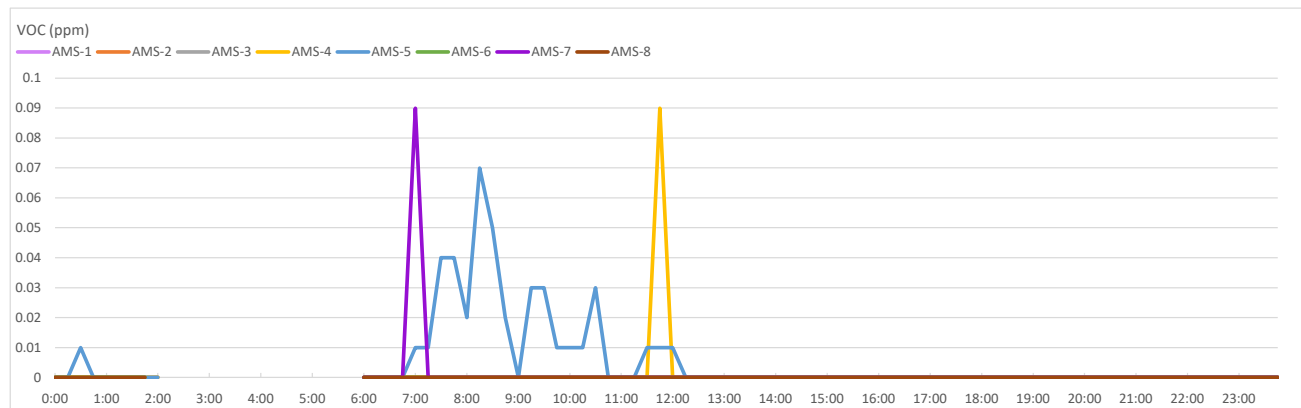

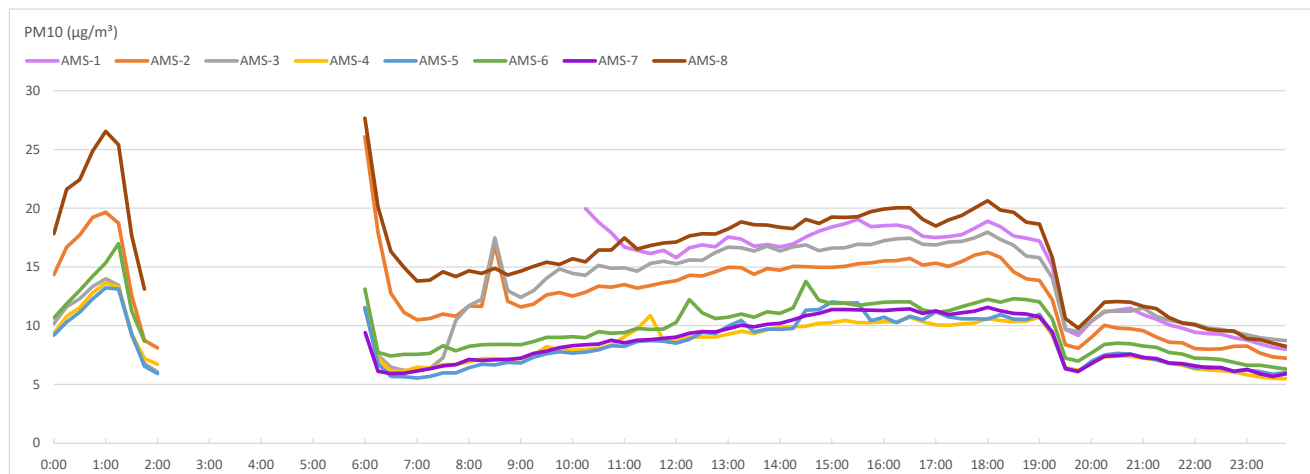

Response Condition (orange) (VOC > 0.75 to <1.0 ppm, PM10 -Not Defined in DEP CAMP)	• Assess site conditions. • Take appropriate dust or vapor control measures including application of water or modification of work activities. • Temporarily halt operations to assess conditions • Note observation in the site log book.
