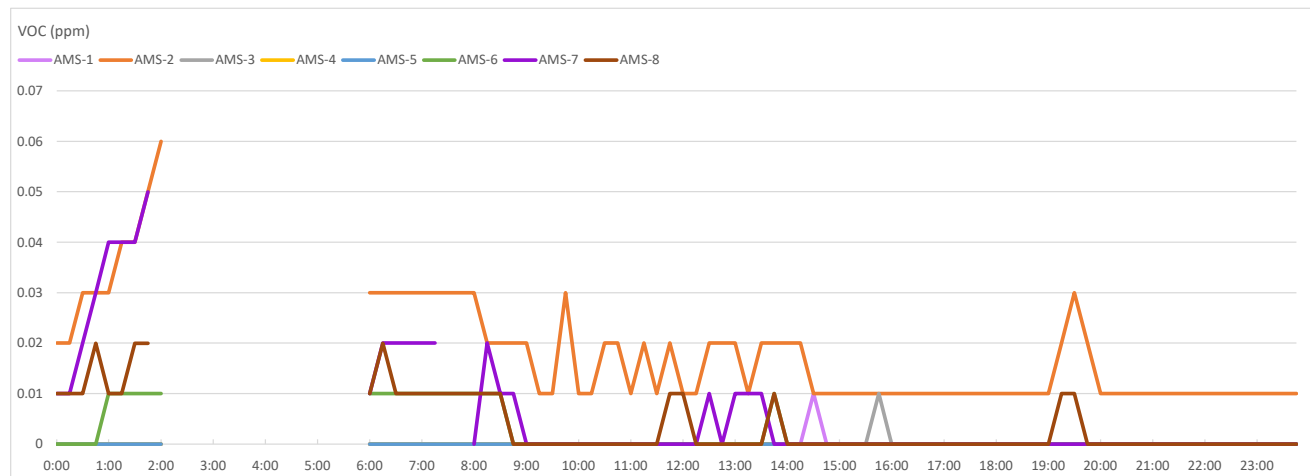

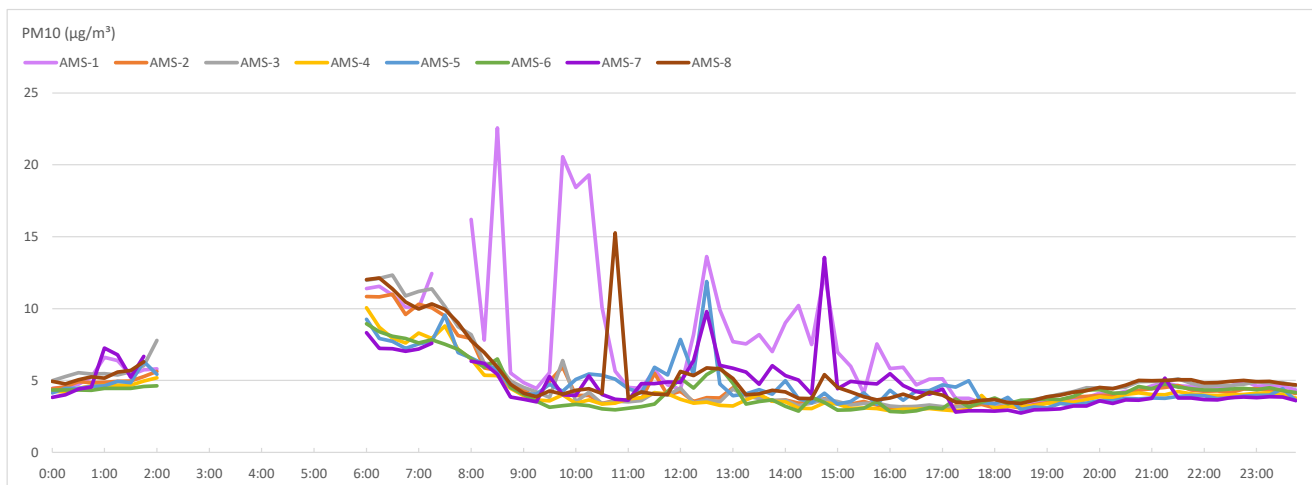

Response Condition (orange) (VOC > 0.75 to < 1.0 ppm, PM10 -Not Defined in DEP CAMP)	- Assess site conditions. - Take appropriate dust or vapor control measures including application of water or modification of work activities. - Temporarily halt operations to assess conditions - Note observation in the site log book.
