

Gowanus CSO Tank - CP2 Daily CAMP Report

This Daily Air Monitoring Report summarizes perimeter air monitoring data collected during the referenced period in accordance with the Community Air Monitoring Plan (CAMP) which was included as part of the requirements of Spec Section 01 57 00 Temporary Controls for the Gowanus CSO-GC-SFS-RH3 CP2 Contract. Note: the information included in this daily summary is based on preliminary results and is subject to change based on data validation.

Summary of Site Activities	1. CAMP monitoring approximately 20 hours a day. 2. Permeation grouting operations, Pin Pile installation, Dewatering well drilling, Cap Beam construction. 3. There were no 15 min average exceedances for VOC. 4. We received PM10 alerts on AMS-1, AMS-2 & AMS-8 on power up. There was no work going on that could have produced these conditions. After an investigation from the CAMP technician water was found in the sampling tubes of the 3 machines. This has happened before on other AMS units and the CAMP technicians are working on a fix.

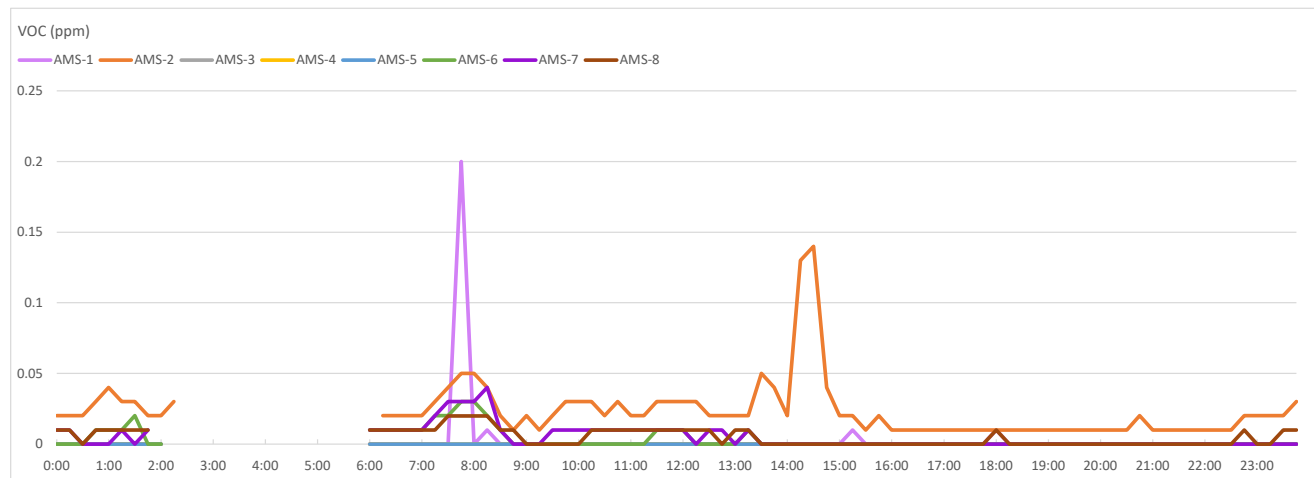

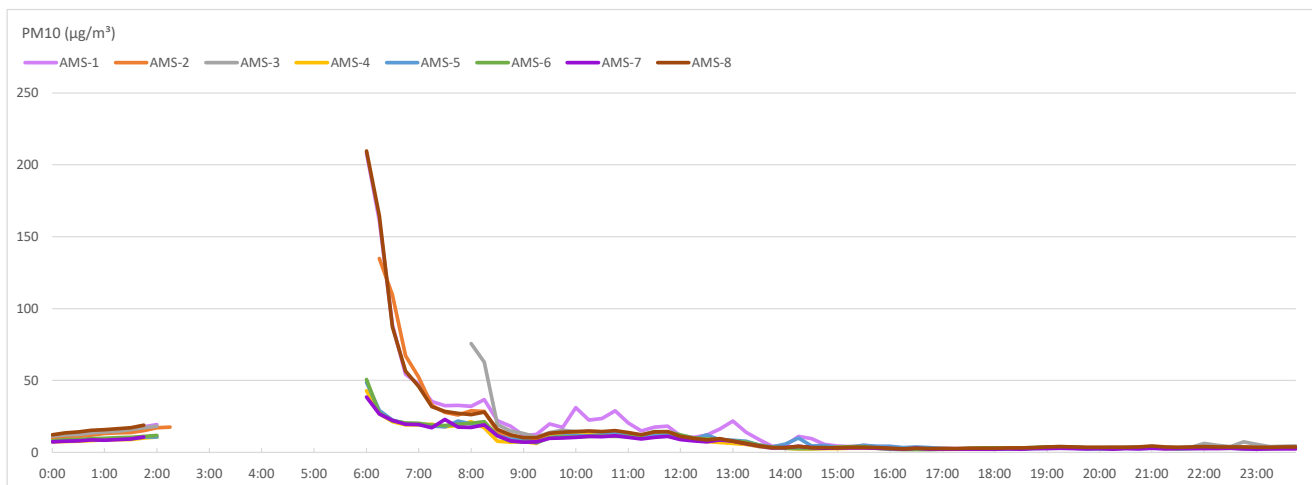
