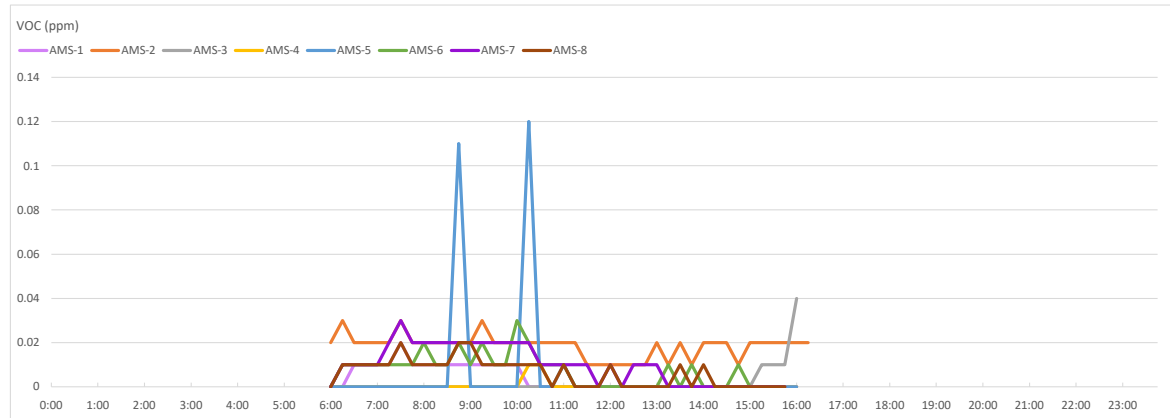

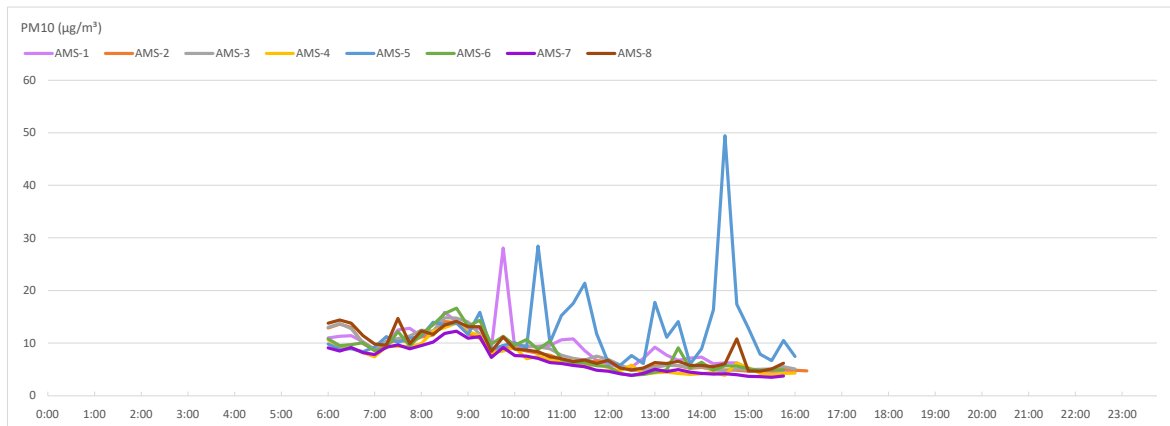

Site Condition	Corrective Action
Operational Condition (green) (VOC ≤ 0.5 ppm, PM10 ≤ 100 ug/m ³)	Normal site operations – No Response Action Required.
Alert Condition (yellow) (VOC > 0.5 and ≤ 0.75 ppm, PM10 > 100 ug/m ³ to ≤ 150 ug/m ³)	Assessment by the Air Monitoring Technician to evaluate potential cause of elevated concentration level. Note observation in the site log book.
Response Condition (orange) (VOC > 0.75 to < 1.0 ppm, PM10 -Not Defined in DEP CAMP)	- Assess site conditions. - Take appropriate dust or vapor control measures including application of water or modification of work activities. - Temporarily halt operations to assess conditions. - Note observation in the site log book.
Action Conditions (red) (VOC ≥ 1.0 ppm, PM10 > 150 ug/m ³)	- Stop current work activity in the Action alarm area. - Run gas chromatography screening on VOC levels greater than 1 ppm to establish potential presence of benzene. - If benzene levels are not detected or are less than 1.0 ppm, work may resume. - Assess site conditions. - Take appropriate action steps to correct conditions. - Commence work activities and monitor air results/concentrations to ensure that corrective measures are effective. - Note observation in the site log book.
