Site Characterization to Begin at Flatbush Station Former Gas Holder

The New York State Department of Environmental Conservation (NYSDEC), New York State Department of Health (NYSDOH) and National Grid (formerly KeySpan) are announcing that the site characterization of a former manufactured gas holder station (“Site”), located between Winthrop Street and Clarkson Avenue and bisected by Parkside Avenue in Brooklyn, New York, will begin in Winter 2010.

Site Description:

The former holder station is located between Winthrop Street and Clarkson Avenue and bisected by Parkside Avenue in Brooklyn, New York. A map showing its location appears on the next page.

Gas distribution structures were present from 1905 to 1979. The construction of the gas holder facility appears to have been completed between 1900 and 1905, and was operated by the Flatbush Gas Co. The facility was comprised of a gas holder to the north of Parkside Avenue, a gas holder located to the south of Parkside Avenue, along with a coal shed, brick oil tank, boiler house, generators, dynamos, carpenter shop, cement storage, lamp house, meter house, and an office building. Based on the layout of these early structures, the Site may have been operated by the Flatbush Gas Co. for the production of manufactured gas. The gas was provided to homes, businesses and industries and used in much the same way natural gas is used today. Site Characterization:

The principal contamination targeted by the site characterization is coal tar, which is the primary by-product associated with manufactured gas sites. Coal tar is a brownish to black liquid with an odor similar to driveway sealer. It contains a variety of environmental contaminants including polycyclic aromatic hydrocarbons (PAHs) and benzene, toluene, ethylbenzene, and xylene (BTEX).

Background:

In 2007, National Grid (then KeySpan) entered into a consent order with the NYSDEC that requires National Grid to investigate and where necessary, remediate former gas manufacturing and storage sites. The former Flatbush Station A&B site is one of the sites that was included in the consent order.

In December, 2010, National Grid will begin a site characterization to determine whether any contamination related to the former gas storage operation exists in the soil or groundwater beneath the Site. Site characterization activities will include drilling of soil borings, installation of groundwater monitoring wells, and collection of soil and water samples for chemical analysis. All work will be done under the oversight of NYSDEC and the NYSDOH.
