Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (the "Registry"). The site identified above, and located on a map on the reverse side of this page, was recently added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

Soil and groundwater at the site are contaminated with chlorinated solvents, primarily tetrachloroethene (PCE) and its breakdown products. Due to the concentrations of PCE detected in groundwater and soil, in conjunction with the proximity of occupied structures to the site, further investigation to evaluate the nature and extent of contamination and the potential for exposures to contamination from the site is warranted.

DEC will keep you informed throughout the investigation and cleanup of the site.

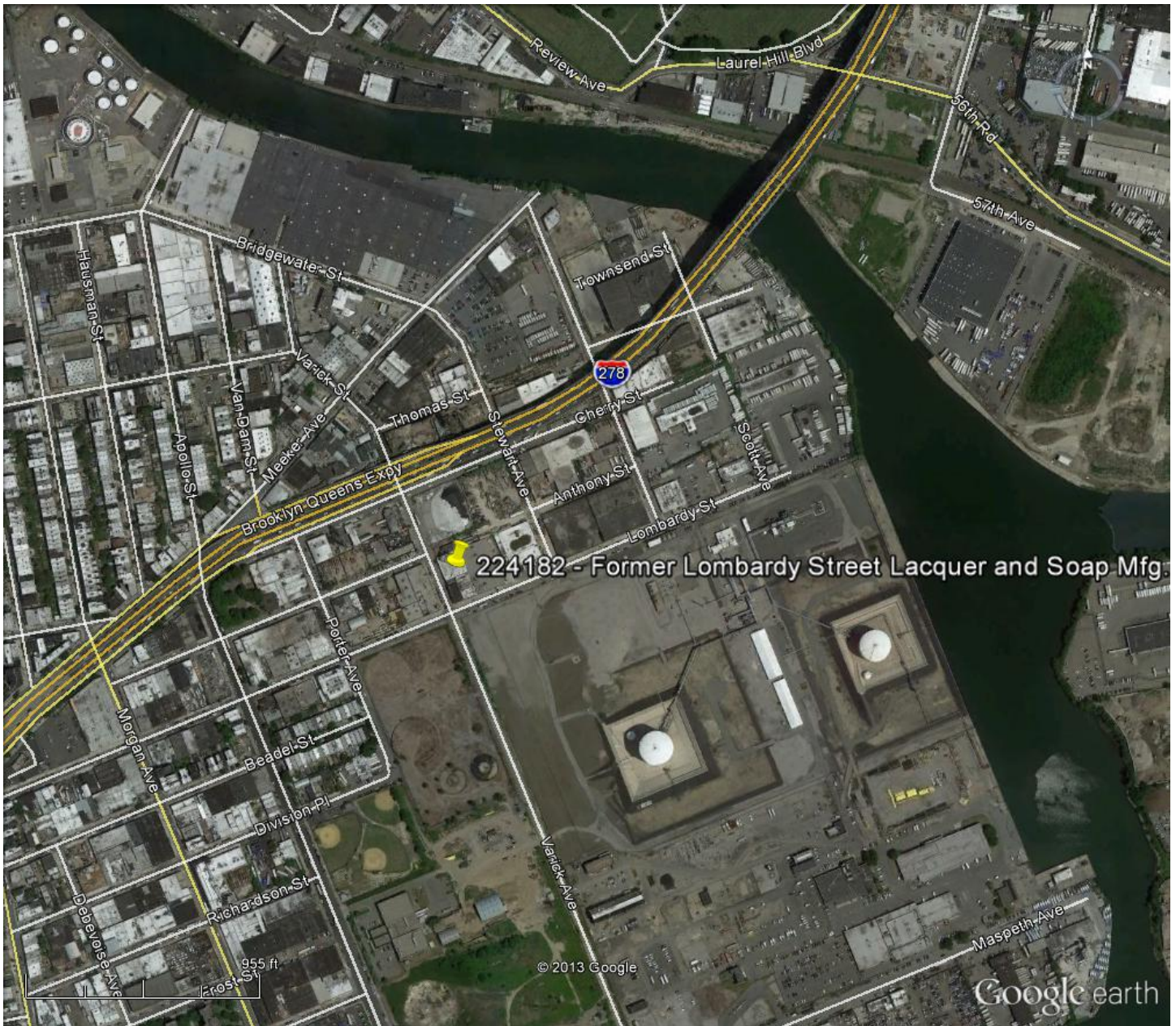
