1.0 EXECUTIVE SUMMARY

Omega Environmental Services was retained by Michael Bialek of ElderServe Health to perform a Phase I Environmental Site Assessment of the site located at 673 Livonia Ave., Brooklyn, NY 11207. This Assessment is related to the potential purchase of the property by The Hebrew Home for the Aged at Riverdale. Omega Environmental Services scope of work was limited to standard ASTM Environmental Site Assessment items.

The purpose of the Environmental Site Assessment was to identify any sources of environmental contamination by reviewing current and historic regulatory information related to environmental conditions and by conducting a visual inspection of the subject property and surrounding vicinity.

The subject property consists of one lot at the SW corner of the intersection of Livonia Ave. and Vermont St. One commercial warehouse type building is present on the site.

According to historic aerial photographs, topo maps, Sanborn Maps, and municipal records, the present building was constructed between 1954 and 1966. From 1966 through 2007 the Sanborn Maps identified the building as "Textile Processing". However, the City Directory lists the site as Fleetwood Cabinet from 1985 through 2017.

Surrounding properties have historically consisted of retail commercial, educational (schools), and residential development.

Based upon a review of the current documentation and regulatory information, and after performing a visual inspection of the site and surrounding area, Omega Environmental has reached the following conclusions:

1. The subject property was identified on the following databases: NY UST, US AIRS, FINDS, and ECHO.
2. The building is heated with fuel oil stored in two 225 gallon ASTs. Records indicate that a 2,500-gallon #2 fuel oil UST was closed prior to 1991. A Phase II sub-surface investigation is presently being conducted and will be submitted under separate cover.
3. Regulatory issues were reviewed within the ASTM radii (up to one mile) of the subject property. No NPL (Superfund) sites, 18 NY LTANKS sites, 4 NY SHWS sites, 1 NY BROWNFIELD site, 1 NY Drycleaners, and various other sites were identified within 1 mile of the property. See section 5.1 for further description of nearby sites.
4. Although no obvious friable ACM was observed (such as thermal insulation) ACM may exist in the form of floor tiles/mastic, ceiling tiles, joint compound, and roofing material. An asbestos survey is being conducted and will be submitted under a separate cover.
5. The presence of Lead-Based Paint (LBP) is suspected due to the age of the building. If the building is to be renovated or demolished, conduct a LBP screening to determine if the demolition Contractor will need to follow OSHA *Lead in Construction Standard*.
6. The Federal EPA Radon Zone for Kings County is Zone 3 – low potential for radon levels above the 4 picoCurie/liter standard.

It is the opinion of Omega Environmental Services that the environmental risk associated with the subject property is low to moderate. The moderate risk is pending the results of the Phase II investigation.

Based on Omega's investigation of the subject site, the following actions are recommended regarding ASTM recognized environmental conditions (RECs) or historic recognized environmental conditions (HRECs):

- **REC (recognized environmental conditions):** Out of service 2,500-gallon #2 fuel oil UST, taken out-of-service prior to 1991. No records of closure were identified. Results of a Phase II investigation are pending.
- **HREC (historic recognized environmental conditions):** Prior use as furniture manufacturer (including spray painting). Results of a Phase II investigation are pending.

Non-ASTM issues identified do not necessarily impact the property value but should be addressed prior to demolition activities:

- If the building is to be renovated or demolished, conduct an asbestos (ACM) survey of materials that may potentially be impacted.
- If the building is to be demolished conduct a Lead-Based Paint (LBP) screen to determine if the demolition contractor will need to follow OSHA *Lead in Construction Standard*.
- Special lead inspection requirements apply to residential use and other buildings with young children present.

2.0 INTRODUCTION

2.1 Purpose:

The purpose of this Environmental Site Assessment was to identify obvious, actual, and potential sources of contamination that, by their association with the site, could become an environmental liability or restrict the use of this property.

2.2 Detailed Scope of Work:

This environmental assessment was conducted in conformance with the requirements of American Society for Testing and Materials (ASTM) Standard E 1527-13; Standard Practice for Environmental Site Assessments; Phase I Environmental Site Assessment Process and the standards for conducting all appropriate inquiries set forth by the United States Environmental Protection Agency (USEPA) at 40 Code of Federal Regulations (CFR) Part 312. The ESA was conducted to evaluate and identify conditions indicative of releases and threatened releases of hazardous substances and petroleum products on, at, in, or to the subject property. The Phase I ESA sought to gather information regarding:

- 1) Current and past property users and occupancies;
- 2) Current and past users of hazardous substances and petroleum products;
- 3) Waste management and disposal activities that could have caused a release or threatened release of hazardous substances;
- 4) Current and past corrective actions and response activities to address past and ongoing releases of hazardous substances at the subject property;
- 5) Engineering controls at the subject property;
- 6) Institutional controls at the subject property; and
- 7) properties adjoining or located near the subject property that have environmental conditions that could have resulted in conditions indicative of releases or threatened releases of hazardous substances to the subject property.

The scope of this Phase I ESA included:

- An on-site inspection of the subject property to evaluate current conditions and identify areas of potential concern;
- A review of the subject property and site area history through interviews and a review of various historical sources as referenced in Section 5 below;
- Observation of adjacent properties and the local area to evaluate the potential for adverse environmental impact to the subject property;
- Research of local city/county, tribal, state, and federal records, including contracting of Environmental Data Resources, Inc. (EDR) to identify regulatory listed sites as required in the regulatory records review section of the ASTM standard for Phase I ESAs, where available; and
- Photographs of the site and surrounding areas were taken to document current conditions and included in Appendix 16.3.

2.3 Significant Assumptions:

It has been assumed that regulatory agency contacts and knowledgeable parties have provided true and accurate information to the best of their knowledge. The subject audit addresses only those areas accessible during the on-site inspection.

2.4 Limitations and Exceptions:

It was not the purpose of this study to determine the presence, degree, or extent of contamination, if any, but rather to address the potential for contamination. Field sampling and laboratory analysis were not performed under the scope of this study. Quantification of any suspect contamination would be addressed in conjunction with Phase II sampling work.

Testing of suspect materials is beyond the Scope of Work of this Assessment.

Omega cannot be held responsible for items (such as floor drains) that have been removed, covered, or otherwise obscured.

2.5 Special Terms and Conditions:

An Environmental Site Assessment is normally valid for a time period of up to 1 year or when site operations/usage change.

2.6 Reliance:

The subject document should be relied upon in terms of the estimated risk of environmental liability only. None of its components should be utilized in lieu of title searching, structural inspections, or other items outside of the scope of work.

This report may only be used as a complete document; sections may not be removed, modified, or utilized in other reports (except as in-context quotes with reference to the entire report) without the inclusion of the complete report herein.

3.0 SITE DESCRIPTION

3.1 Location and Legal Descriptions:

The subject property consists of one lot at the SW corner of the intersection of Livonia Ave. and Vermont St. One commercial warehouse-type building is present on the site.

The site is identified as Block 3808, Lot 1, Borough of Brooklyn, Kings County, NY.

3.2 Site History

According to historic aerial photographs, topo maps, Sanborn Maps, and municipal records, the present building was constructed between 1954 and 1966. From 1966 through 2007, the Sanborn Maps identified the building as “Textile Processing”. However, the City Directory lists the site as Fleetwood Cabinet from 1985 through 2017.

3.3 Site and Vicinity Characteristics:

The site coordinates are 40 degrees, 39’, 55.14” Latitude, 73 degrees, 53’, 30.84” Longitude. The site is located approximately 29 feet above sea level. The USGS 7.5 min. quad index map associated with the property is identified as 5940597 Brooklyn, NY 2013.

Surrounding properties have historically consisted of retail commercial, educational (schools), and residential development.

3.4 Soils, Geology, and Hydrogeology

The soil component identification is “Urban Land”. No further information related to these specific soils was readily available. Nearby soils consist of loam and coarse-grained soils.

No unusual surface conditions that would indicate settling were noted.

No Federal FRDS Public Water Supply wells, ten Federal USGS wells, and no State Database wells were identified within and 1 mile distant from the site on the databases searched.

This is not intended to be a complete local well search, only a screening of database information.

The site is not located in or within 1 mile of a 0.2% Annual Chance Flood Hazard zone of a Special Flood Hazard Area (1%).

3.5 Description of Structures

The subject property consists of a 10,000 sq. ft. lot containing a 1-story slab-on-grade warehouse building. A driveway exists along the northern side of the building.

3.6 Description of Uses of Property, Operations, and Utilities

Processes, Material Uses, and Storage - Historic

Based on aerial photographs and Sanborn Maps the building was constructed between 1954 and 1966.

According to Sanborn Maps, the building was identified as “Textile Processing” from 1966 to 2007. However, this contradicts some other data (such as the City Directory). The discrepancy is expected to be a lack of updating the Sanborn Maps.

Specific operations are only identified as a knitting mill, cleaners, and finishers. No further information was available at this level of investigation.

From 1985 through 2017 the building was occupied by a furniture manufacturer. Based on the site reconnaissance the operations included spray painting of furniture. Information as to specific products used was not available.

Hazardous Waste

No records of hazardous waste generation or disposal were identified for the subject property.

Fuel Sources - ASTs/USTs

The building is presently heated with # 2 fuel oil stored in two 250-gallon ASTs located inside the building.

Previously (pre-1991) fuel was stored in a 2,500 gallon UST located in the northern driveway. No records of UST closure were readily available.

A Phase II investigation is being conducted in the suspected area of the UST. The location of the investigation is based on the presence of a UST vent pipe.

The results of the Phase II investigation will be submitted under separate cover.

Other ASTs

No other ASTs were identified on the subject property.

Water Supply, Wastewater, and Storm Water

Water, gas, sewer disposal, and electricity are supplied by the local utilities. No on-site sewer disposal is known to have occurred on the site.

There are no indications of an active on-site well (for water supply) on the subject property.

ACM, LBP

Although no obvious ACM was observed (such as thermal insulation) ACM may exist in the form of floor tiles/mastic, ceiling tiles, joint compound, and roofing material. Concealed ACM may also exist. Conduct an ACM survey if prior to significant renovation activities.

The presence of Lead-Based Paint (LBP) is suspected due to the age of the building.

3.7 Previous/On-going Investigations:

A Phase I ESA was conducted by The Environmental Group (report dated August 18, 2016). Although this ESA identified two Recognized Environmental Conditions (RECs – one inactive UST and two active ASTs) it did not recommend any further actions.

3.8 Current and Previous Uses of Adjoining Properties:

Surrounding properties have historically consisted of retail commercial, educational (schools), and residential development.

Adjacent properties presently consist of the following:

- Northerly perimeter: residential
- Southerly perimeter: retail commercial and residential
- Easterly perimeter: retail commercial and residential
- Westerly perimeter: retail commercial and residential

4.0 USER-PROVIDED INFORMATION

4.1 Title Records:

A title search has not been performed for this property by Omega Environmental Services.

4.2 Environmental Liens:

No environmental lien issues were identified in conjunction with the database search.

4.3 Specialized Knowledge:

No other significant specialized knowledge was noted, other than that which is described elsewhere in this report.

4.4 Valuation Reduction for Environmental Issues:

No valuation reduction items were noted, pending the results of the Phase II investigation.

4.5 Owner, Property Manager, and Occupant Information:

The present owner was not identified in this investigation. The property is presently vacant.

4.6 Reason for performing the Environmental Site Assessment:

The reason for performing this assessment is the potential purchase by The Hebrew Home for the Aged at Riverdale.

5.0 RECORDS REVIEW

5.1 Standard Environmental Records:

The “Environmental Data Resources, Inc.” (EDR) ASTM Radius “search package” is a computer-generated map produced with the aid of Geographic Information System (GIS) technology. A fully automated search technique is used to produce the map, which does not manually research or plot non-geocoded facilities. Plotted on the map are hazardous waste and other “listed” facilities within the search radius.

Due to limitations of the GIS system, some of the distances and directions may be slightly inaccurate. Also, the *distances shown are from the subject property street address to the database property street address, not from property line to property line.* This can be significant when addressing large facilities.

No National Priorities List sites (NPL, or Superfund site) were identified within one mile of the site.

The subject property was identified on the following databases: NY UST, US AIRS, FINDS, and ECHO. USAIRS, FINDS, and ECHO are general tracking databases expected to be related to the previous furniture manufacturing operations.

The UST is shown on the database as “unregulated/closed”. It is identified as a 2,500-gallon #2 fuel oil UST that was reportedly “closed prior to Micro Conversion, 03/91”

Generally, the DEP does not hold the owner of a property that receives contamination (usually through groundwater migration) from an off-site source responsible for remediation. However, contamination from any source can reduce the subject property value and incur costs to subject property associated with proving that the source of contamination is from off-site sources.

5.2 Additional Environmental Records:

Radon - The EPA radon office information was accessed to determine the potential for radon levels above the 4 picoCurie/liter standard. Based on area averages, the site has a low potential for radon levels above this standard.

5.3 Sources of Physical Setting Information:

Omega Environmental Services reviewed available sources of information relating to the geology of the subject property and surrounding areas. The purpose of this review was to evaluate the sensitivity of the potential contamination from sources on or near the subject property. It was not the purpose of this study to evaluate the geotechnical conditions of the site or to assess engineering concerns such as foundation conditions, faulting, or subsidence.

5.4 Sources of Historical Use Information of the Property:

The “EDR Search Package”, Sanborn Maps, Historic Aerial Photographs, and Historic Topo Maps were utilized for historic uses of the property. Sanborn Maps were available for the subject property for the following years: 1887, 1908, 1928, 1950, 1966, 1977, 1979, 1981, 1983, 1986, 1987, 1989, 1991, 1994, 1995, 1996, and 2001 through 2007. Historic Aerial Photographs were available for the following years: 1954, 1966, 1980, 1984, 1994, 2004, 2006, 2008, 2009, 2011, 2012, 2013, 2015, and 2017. Historic Topo Maps were available for the following years: 1889, 1891, 1898, 1900, 1903, 1905, 1906, 1908, 1910, 1916, 1924, 1931, 1938, 1947, 1948, 1958, 1959, 1961, 1966, 1967, 1970, 1975, 1979, 1999, 2013, 2016, and 2019.

5.5 Sources of Historical Use Information of Adjoining Properties:

The above-listed resources were utilized to obtain information on the adjoining properties.

6.0 SITE RECONNAISSANCE

6.1 Methodology and Limiting Conditions:

Interior

Site reconnaissance work is limited to those areas accessible at the time of the on-site inspection. Virtually the entire interior space was inspected.

Soil

Since soil under sidewalks, asphalt paving, and the building foundations are not accessible for inspection, specific evaluation of its potential for contamination (i.e. staining) is not feasible.

6.2 General Site Setting:

Surrounding properties have historically consisted of retail commercial, educational (schools), and residential development.

6.3 Exterior Observations:

Topography

No unusual surface conditions (such as would indicate settling) were observed during the site investigation. The property is relatively level.

Surrounding land is generally level, sloping slightly down gradient to the south and east.

Evidence of Potential Contamination

Based on visual inspection, there was no *visual* evidence of contamination (no unusual odors, staining, or distressed vegetation) around the exterior of the building.

Underground Storage Tanks (USTs) and Aboveground Storage Tanks

A 2,500-gallon #2 fuel oil UST was reportedly located under the northern driveway. The only remaining visual indication of the location of the UST is a UST vent pipe. The UST was reportedly taken out-of-service prior to 1991. However, no records were available regarding the formal closure of the UST. It is not known whether the UST was removed or closed in place. See further discussion in the pending Phase II investigation of the UST (under separate cover).

Transformers/PCBs

No suspected PCB-containing transformers were noted.

Chemical Storage

No present chemical storage was noted around the exterior of the building.

6.4 Interior Observations:

Chemical Storage

One unlabeled 55-gallon drum was identified inside the building. The drum seemed to be free of liquids and is suspected of being associated with previous furniture spraying operations. Solid residue exists on the drum and likely inside the drum.

Evidence of Chemical Contamination

No visual indications of significant chemical contamination were noted. However, overspray from the previous furniture manufacturing operations was present on the floor slab and walls.

Transformers

No transformers were observed in the interior of the building.

ASTs/USTs

Two active 250-gallon ASTs are located inside the building outside the rear boiler room. They appear to be in good condition with no signs of leaks.

7.0 INTERVIEWS – Site information was provided primarily through direct observation, records research, Sanborn Maps, and Historical Aerial Photographs.

8.0 FINDINGS/RECs

Soils/Geology

No unusual soil conditions were noted (such as settling, or shifting).

Potential onsite contamination

Potential contamination from the out-of-service fuel oil UST and the historic uses of the building are being investigated in a separate Phase II investigation.

Radon

According to the EPA Radon office, the Radon Zone for Kings County is Zone 3 – low potential for radon levels above the 4 picoCurie/liter standard.

Underground Storage Tank (UST) and Aboveground Storage Tanks (AST)

No further action is recommended in regards to the active fuel oil ASTs, other than normal maintenance.

Potential contamination from the out-of-service fuel oil UST and the historic uses of the building are being investigated in a separate Phase II investigation.

Transformers/PCBs

- Transformers – none of concern identified.

Database Search

No nearby sites of significant concern were noted.

Miscellaneous

- None.

9.0 OPINION

It is the opinion of Omega Environmental Services that the environmental risk associated with the subject property is low to moderate. The moderate risk is pending the results of the Phase II investigation.

10.0 CONCLUSION/RECOMMENDATIONS

It is the opinion of Omega Environmental Services that the environmental risk associated with the subject property is low to moderate.

Based on Omega's investigation of the subject site, the following actions are recommended regarding ASTM recognized environmental conditions (RECs) or historic recognized environmental conditions (HRECs):

- **REC (recognized environmental condition):** Out of service 2,500-gallon #2 fuel oil UST. Taken out of service prior to 1991. No records of closure were identified. Results of a Phase II investigation are pending.
- **HREC (historic recognized environmental condition):** Prior use as furniture manufacturer (including spray painting). Results of a Phase II investigation are pending.

Non-ASTM issues identified do not necessarily impact the property value but should be addressed prior to demolition activities:

- If the building is to be renovated or demolished, conduct an asbestos (ACM) survey of materials that may potentially be impacted.
- If the building is to be demolished conduct a Lead-Based Paint (LBP) screen to determine if the demolition contractor will need to follow OSHA *Lead in Construction Standard*.
- Special lead inspection requirements apply to residential use and other buildings with young children present.

11.0 DEVIATIONS

The subject Environmental Site Assessment did not deviate from ASTM protocol.

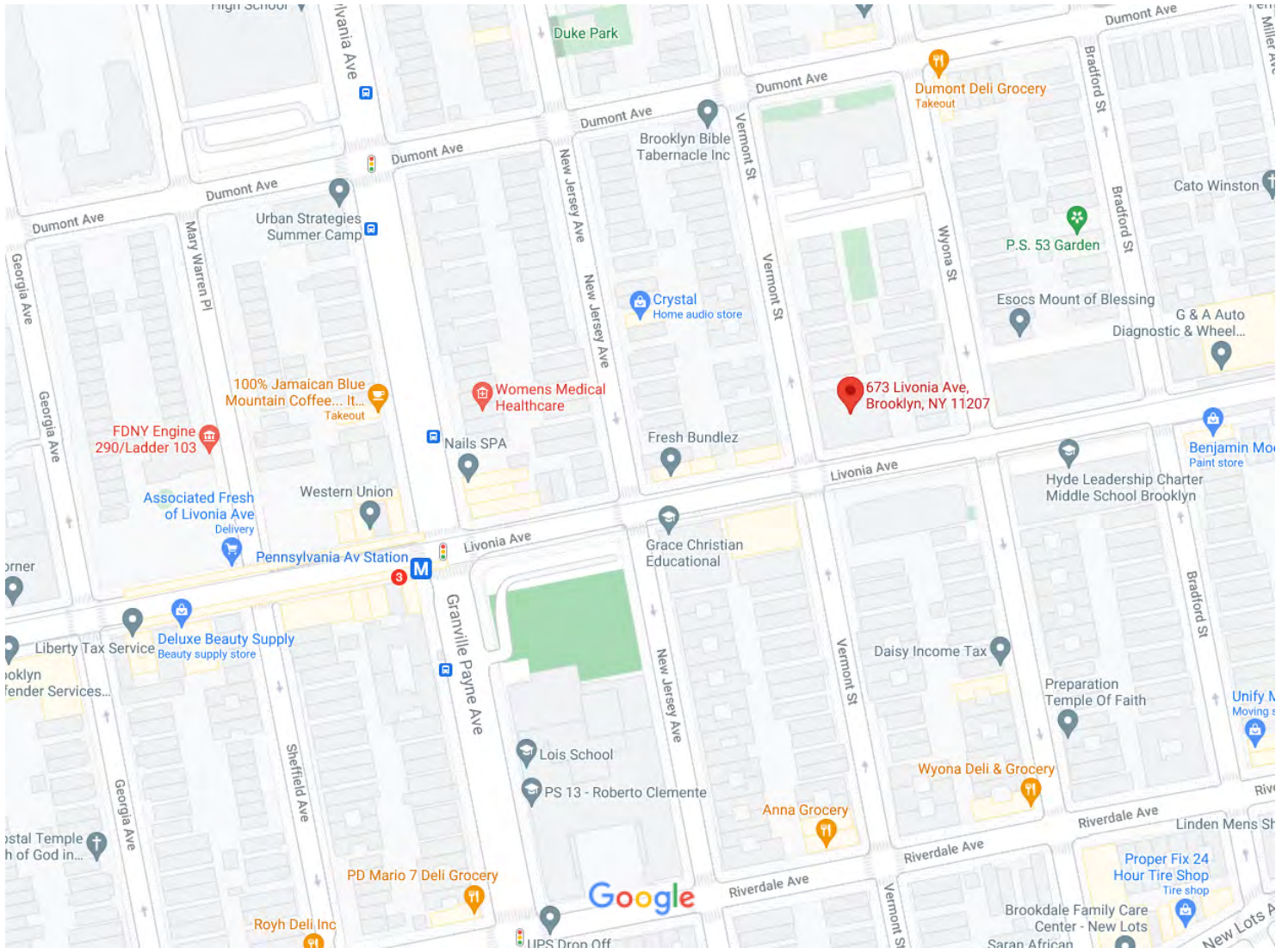
