This biweekly Community Air Monitoring Program (CAMP) report has been prepared on behalf of Consolidated Edison of New York, Inc. (Con Edison) for the Interim Corrective Measure (ICM) activities being conducted at the Astoria East Transformer Yard (the Site) located in Con Edison's Astoria Facility in Queens, New York, under the NYSDEC-approved 2014 ICM Plan and USEPA-approved 2022 Final PCB Self-Implementing Cleanup Plan (SICP). All CAMP monitoring activities are performed by JMG Engineering (JMG), a subcontractor to Con Edison's contractor (D'Onofrio General Contracting Corporation [DGCC]) and/or DGCC personnel. A summary of daily CAMP monitoring is presented below.
