- The New York State Department of Environmental Conservation (the "Department") entered an Order on Consent with Respondents Kinder Morgan Liquids Terminals LLC ("Kinder Morgan"), ExxonMobil Oil Corporation ("ExxonMobil") and NP Staten Island Industrial, LLC ("NorthPoint") in the within matter on September 15, 2020.
- 2. Pursuant to Section VII.B. of the Order on Consent, Respondent NorthPoint was entitled to provide a written notice to the Department by no later than October 30, 2020 stating that it had not and would not be completing its contemplated purchase of the Facility site (as defined in the Order on Consent) and, in the event that NorthPoint provided said notice, NorthPoint would be released from the Order on Consent and from all requirements and obligations established thereby.
- 3. In order to provide an extended period for the consummation of its contemplated purchase of the Facility site, NorthPoint has requested that the October 30, 2020 deadline for the provision of such notice be extended to December 31, 2020.

- III. This Amendment to the Order on Consent shall take effect when it is signed by Respondents and a designee of the Commissioner.


