The purpose of this letter is to provide you with the required annual update of our Solid Waste Management Unit (SWMU) Inventory pursuant to Module II.C.1 of the above referenced Part 373 Permit. This update is for the calendar year 2015.

No new SWMUs were added to the facility inventory in 2015, but the following revisions have been made in the attached Annual Solid Waste Management Unit (SWMU) Inventory Update table below. Units with status changes in B330C, B330D, and B338 were removed as part of the MLC End of Life Project. Building 309 rooms #2, #7, and #8 were closed in accordance with the NYSDEC approved Closure Plan and Quality Assurance Project Plan (QAPP). The remaining changes were made based on field review of the units.

A copy of the updated NYSDEC Part 373 Permit Document, Module II Corrective Action, Appendix II-E Solid Waste Management Unit Location Map, dated 5/20/16, is included. Minor changes were made to the mapped locations of SWMUs within B/338, B/330C, and B/330D based on field review of the units.
