# State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

Sampling of on-site groundwater and soil, surface water and sediment of the Fall Kill and nearby
drinking water wells indicates the presence of poly- and per-fluoroalkyl substances (PFAS). Additional
investigation is needed to: define the nature and extent of contamination; evaluate associated human
exposure pathways; and, determine the appropriate actions that will need to be implemented to
prevent and mitigate potential exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.


