Remedy Proposed for Former Manufactured Gas Plant Site Operable Unit 1 Public Comment Period and Public Meeting Announced

The public is invited to comment on the remedy proposed by the New York State Department of Environmental Conservation (NYSDEC) to address environmental impacts related to the Clove and Maple Former Manufactured Gas Plant (MGP) Site. The site is located at Clove and Maple Avenues, Village of Haverstraw, Rockland County. The site is divided into three operable units. An operable unit represents a portion of a site that can be addressed separately. Operable Unit 1 (OU1) is the on-site source area and drainage swale. OU1 is currently owned by O&R. OU2 consists of off-site properties including single family residential properties, an apartment complex, a portion of an alleyway, and a portion of Maple Avenue. OU3 consists of sediments in the Hudson River embayment located close to the site. See the attached map for the site and OU locations.

NYSDEC invites you to a public meeting to discuss the remedy proposed for this site. You are encouraged to provide comments at the meeting and during the 30-day comment period described in this fact sheet.

The Proposed Remedy

The remedy proposed for OU1 includes excavating soils that contain levels of contamination above the restricted residential level and capping the site with clean soil. Impacted surface soils will also be removed and replaced with a 2-foot soil cover.

The proposed remedy is described in plan called a "Proposed Remedial Action Plan" (PRAP). It is available for public review at the locations identified below under "Where to Find Information".

How to Comment

NYSDEC is accepting written comments about the proposed remedy for 30 days, from February 25, 2011 through March 28, 2011.

Summary of the Proposed Remedy

The proposed remedy for OU1 represents the alternative preferred by NYSDEC and the New York State Department of Health (NYSDOH) to address site impacts. The PRAP includes:

- Demolition and proper disposal of concrete holder pad located at the surface in the northwest portion of the property.
- Excavation of approximately 15,000 cubic yards (CY) of impacted subsurface soil.
- Removal of approximately 1,300 (CY) of surface soil outside the area of the soil excavation, to a depth of 2 feet. Placement of 2 feet of soil cover to satisfy Restricted Residential Soil Cleanup Objectives.
- Groundwater monitoring to assess cleanup effectiveness.
- A Site Management Plan to restrict groundwater use on the property.

The proposed remedy was chosen following a detailed investigation of the site and evaluation of alternatives to address MGP impacts, called a “Remedial Investigation/Feasibility Study”. Other alternatives presented in the Feasibility Study include no action, capping and removal of contaminated soil to varying degrees. The proposed remedy would achieve the remediation goals for the site by permanently removing contaminated soil from the site. The proposed remedy would greatly reduce the source of MGP impacts to groundwater, and it would create the conditions needed to restore groundwater quality to the extent possible.

Proposed remedies for OU2 and OU3 will be identified in separate cleanup plans.

Next Steps

NYSDEC will consider public comments as it finalizes the remedy for the site. The selected remedy will be described in a document called a “Record of Decision” that will explain why the remedy was selected and respond to public comments. This document will be made available to the public (see “Where to Find Information” below). The project then moves to designing and performing the cleanup action to address the site contamination.

NYSDEC will keep the public informed during the cleanup of the site.

Background

The Clove and Maple Avenues Manufactured Gas Plant (MGP) parcel, approximately one acre in size and is owned by Orange & Rockland Utilities, Inc. It began operations in the late 1800s and produced gas using the carbureted water gas method until approximately 1935 when natural gas began to be distributed. Former MGP structures were demolished in the 1960s and a retired gas regulator station is the only remaining structure on the fenced property. The gas regulator station was decommissioned by O&R in 2007. Adjacent land use includes residential and multi-family residential properties.

Orange & Rockland performed a series of environmental studies at the site and nearby properties, beginning with an initial assessment in 1996 and a Preliminary Site Assessment in

1997. The Remedial Investigation (RI) was initiated in 1998, with multiple phases of field work, analysis, and review. This investigation resulted in a series of reports, culminating in the DEC-approved Remedial Investigation Report (RIR) dated May 2009 (CMX, 2009) and Feasibility Study dated September 2010.

The primary contaminant of concern at this site is coal tar, a brownish to black substance with an odor similar to driveway sealer. Coal tar contains chemicals including polycyclic aromatic hydrocarbons (PAHs) and benzene, toluene, ethylbenzene, and xylene (BTEX).



Saneamiento propuesto para la unidad operable 1 del emplazamiento de la antigua planta de gas sintético

Anuncio de reunión pública y periodo de opinión pública

Se invita al público a dar su opinión sobre el saneamiento propuesto por el Departamento de Conservación del Medio Ambiente del Estado de Nueva York (New York State Environmental Conservation, NYSDEC) para tratar los impactos medioambientales relacionados con el emplazamiento de la antigua planta de gas sintético (Manufactured Gas Plant, MGP) entre Clove y Maple. El emplazamiento se encuentra ubicado entre las avenidas Clove y Maple, en la localidad de Haverstraw, Condado de Rockland. El emplazamiento está dividido en tres unidades operables. Una unidad operable representa una parte de un emplazamiento que puede tratarse por separado. La unidad operable 1 (Operable Unit 1, OU1) constituye la acequia de drenaje y el área de fuente dentro del emplazamiento. Actualmente, la OU1 pertenece a O&R. La OU2 está conformada por propiedades que se encuentran fuera del emplazamiento, las cuales incluyen propiedades residenciales individuales, un complejo de departamentos, una parte de un callejón y una parte de la avenida Maple. La OU3 está conformada por sedimentos de la ensenada del río Hudson que se encuentra cerca del emplazamiento. Consulte el mapa adjunto para conocer la ubicación de las unidades operables y del emplazamiento.

El Departamento de Conservación del Medio Ambiente del Estado de Nueva York (New York State Department of Environmental Conservation, NYSDEC) le invita a una reunión pública para analizar el saneamiento propuesto para este emplazamiento. Está invitado a que dé su opinión en la reunión y durante el período de opinión de 30 días que se describe en esta hoja informativa.

Saneamiento propuesto

El saneamiento propuesto para la OU1 incluye la excavación de los suelos que contienen niveles de contaminación superiores al nivel residencial restringido y la aplicación de suelo limpio sobre el emplazamiento. Los suelos superficiales afectados también se retirarán y se reemplazarán por una capa de suelo de 2 pies (61 cm).

El saneamiento propuesto se describe en el plan que se denomina “Plan de Acción Propuesto para el Saneamiento” (“Proposed Remedial Action Plan”, PRAP). Se encuentra a disposición del público en los lugares que se identifican más adelante, en la sección “Dónde encontrar información”.

Resumen del saneamiento propuesto

El saneamiento propuesto para la OU1 representa la alternativa que prefieren el NYSDEC y el Departamento de Salud del Estado de Nueva York (New York State Department of Health, NYSDOH) para tratar los impactos en el emplazamiento. El PRAP incluye lo siguiente:

- La demolición y la eliminación correcta del bloque de soporte de cemento que se encuentra en la superficie de la parte noroeste de la propiedad.
- La excavación de aproximadamente 15,000 yardas cúbicas (11,470 m³) de suelo subsuperficial afectado.
- El retiro de aproximadamente 1,300 yardas cúbicas (994 m³) de suelo superficial fuera del área de excavación del suelo, a una profundidad de 2 pies (61 cm). La colocación de 2 pies (61 cm) para cumplir con los objetivos de limpieza de suelo residencial restringido.
- La supervisión del agua subterránea para evaluar la eficacia de la limpieza.
- Un Plan de Administración del Emplazamiento para restringir el uso del agua subterránea de la propiedad.

El saneamiento propuesto se eligió a partir de una investigación detallada del emplazamiento y una evaluación de las alternativas para tratar los impactos de MGP que se denomina “Estudio de Viabilidad/Investigación sobre Saneamiento”. Otras alternativas presentadas en el Estudio de Viabilidad incluyen la inacción, la aplicación de suelo y la extracción del suelo contaminado a distintos grados. El saneamiento propuesto logaría los objetivos de saneamiento para el sitio mediante la extracción permanente del suelo contaminado del emplazamiento. El saneamiento propuesto reduciría de manera significativa la fuente de impactos de la MGP en el agua subterránea, y crearía las condiciones necesarias para restaurar la calidad del agua subterránea en la medida de lo posible.

Los saneamientos propuestos para OU2 y OU3 se identificarán en planes de limpieza por separado.

Próximos pasos

El NYSDEC analizará la opinión pública cuando concluya el saneamiento del emplazamiento. El saneamiento seleccionado se describirá en un documento que se denomina “Registro de Decisión”, en el cual se explicarán los motivos por los que se seleccionó el saneamiento y se responderá la opinión pública. Este documento se pondrá a disposición del público (consulte la sección “Dónde encontrar información” que figura más abajo). El proyecto luego pasa a la etapa de diseño y de concreción de la acción de limpieza para tratar la contaminación del emplazamiento.

El NYSDEC mantendrá al público informado durante la limpieza del emplazamiento.

Antecedentes

La parcela de la planta de gas sintético (MGP) entre las avenidas Clove y Maple posee una superficie de un acre (4,000 m²) y pertenece a Orange & Rockland Utilities, Inc. (O&R). Comenzó a funcionar a fines del siglo XIX y produjo gas mediante el método de gas de agua carburado hasta aproximadamente 1935, cuando se comenzó a distribuir gas natural. Las antiguas estructuras de MGP se demolieron en la década del sesenta y la única estructura que quedó en el predio cercado fue una estación reguladora de gas abandonada. La estación reguladora de gas fue desmantelada por O&R en 2007. El uso de los terrenos aledaños incluye propiedades residenciales multifamiliares y residenciales.

Orange & Rockland realizó una serie de estudios medioambientales en el emplazamiento y en

predios aledaños, los cuales comenzaron con una evaluación inicial en 1996 y una evaluación preliminar del emplazamiento en 1997. La Investigación sobre Saneamiento comenzó en 1998, con múltiples fases de trabajo de campo, análisis y revisión. Esta investigación produjo una serie de informes que sirvieron para elaborar el Informe de la Investigación sobre Saneamiento (Remedial Investigation Report, RIR) de mayo de 2009 (CMX, 2009) y el Estudio de Viabilidad de septiembre de 2010, que ha sido revisado y aprobado por el Departamento de Conservación del Medio Ambiente.

El contaminante de mayor preocupación en este emplazamiento es el alquitrán de carbón, una sustancia pardusca a negra que presenta un olor similar al de un sellador para entradas de automóviles. El alquitrán de carbón contiene sustancias químicas que incluyen hidrocarburos aromáticos policíclicos (HAP), benceno, tolueno, etilbenceno y xileno (BTEX).


