State Superfund Site Reclassification Notice Class 02 to Class 04

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- Remedial actions have been completed at the site which include the excavation of contaminated soil, use of a soil vapor extraction system, use of a groundwater pump and treat system for the near-field groundwater plume and development of a new water district to provide an alternate water source to residences and businesses in the impacted area. Soil vapor mitigation is also installed in the on-site commercial building.
- The site is subject to institutional controls that prevent the use of groundwater as a drinking water source and require continued operation of the on-site soil vapor extraction systems. There is a groundwater monitoring program in place to evaluate the effectiveness of the remedy.

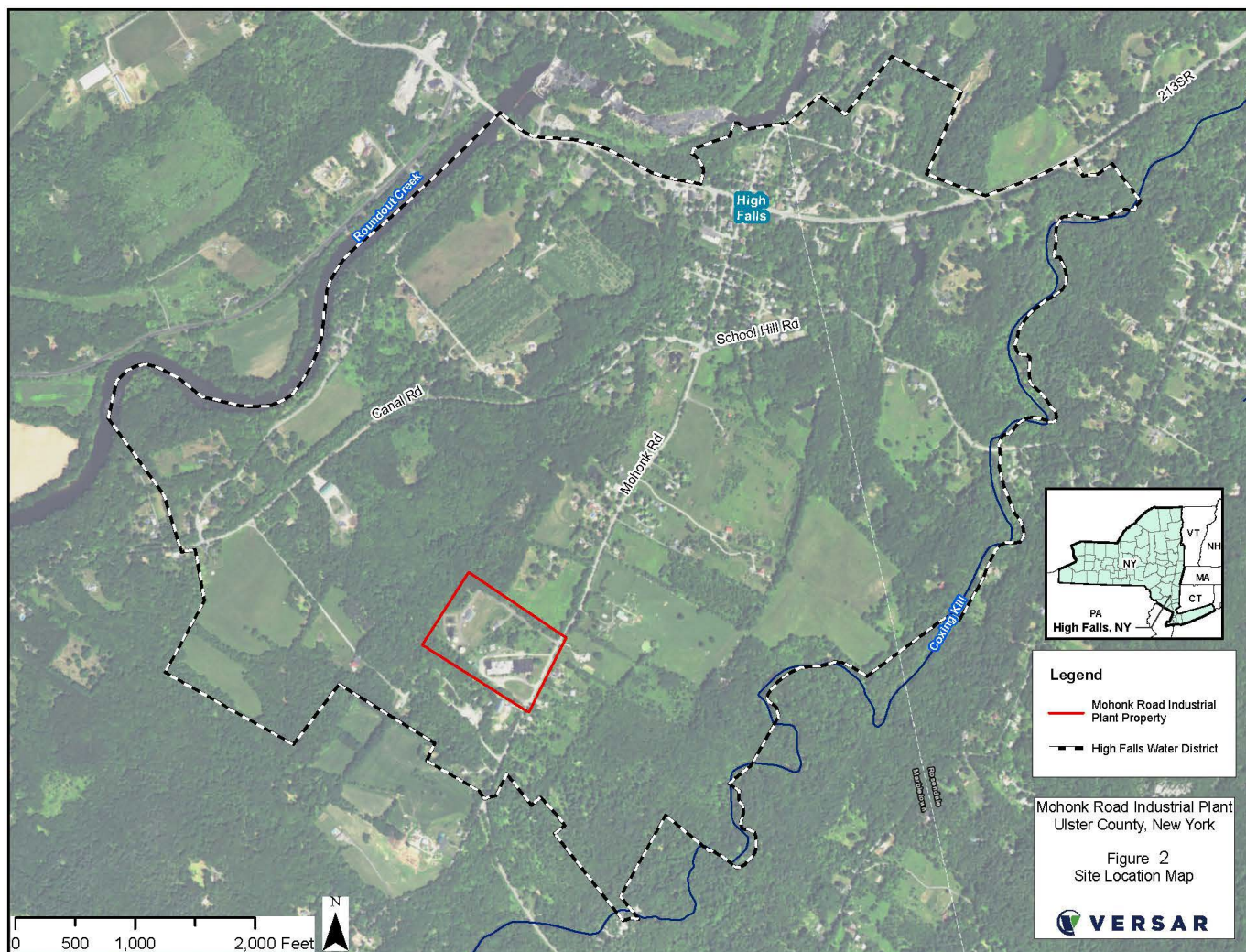
