Comments:

On behalf of Rohm and Haas (a wholly owned subsidiary of The Dow Chemical Company), URS Corporation along with Zebra Environmental will implement substrate injections at the Former EMCA Site, now owned and operated by Cablevision of Westchester at 609 Center Avenue in Mamaroneck, New York. The purpose of the injections is to remediate Freon 113 in groundwater at the site. The work is being accomplished pursuant to a consent agreement with and under the jurisdiction of the New York State Department of Environmental Conservation. This is the fourth series of injections to address the Freon plume. Proprietary food-grade products, including emulsified soybean oil and sodium lactate (the same substrate materials used in previous injections), will be injected into the subsurface to promote the anaerobic biodegradation of Freon 113 and its daughter products. A direct-push Geoprobe unit will advance the temporary injection points to a maximum depth of 25 feet below ground surface and the substrate will be injected at 4-foot intervals as the probe is being withdrawn until a depth of 5 feet below ground surface is reached. The water table beneath the site varies between approximately 4 to 6 feet below ground surface. All previous injection points were abandoned by backfilling with bentonite and returning the surface to pre-injection conditions; these points will be abandoned in a similar manner.
