### Remedial Investigation Complete and Remedy Proposed for Former Manufactured Gas Plant Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed remedy being reviewed by the New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), to address contamination related to the Former Cedar Street Manufactured Gas Plant (MGP) site ("site") located under the Cedar Street right of way and 47 Cedar Street, New Rochelle, New York County. Please see the map for the site location.

**How to Comment:** NYSDEC is accepting written comments about the proposed plan for 30 days, from **November 6 through December 6, 2019**.

The site is the subject of an Order on Consent between Consolidated Edison Company of New York, Inc. (Con Edison) and the New York State Department of Environmental Conservation (NYSDEC).

Alternatives Analysis Report: The proposed Restricted Use remedy consists of:

- Installation of a coal tar collection system to recover potentially mobile tar;
- Recording of an Environmental Easement to ensure proper use of the portion of the site which is not located underneath a right of way or a road.
- Implementation of a Site Management Plan (SMP) which provides details on long term maintenance and monitoring of the remedial systems, managing potentially impacted material during intrusive activities, requirements for future investigations should buildings at the site be demolished, and how institutional controls (i.e. environmental easement, and municipal & NYSDOT notification mechanisms, etc.) are to be implemented and certified.


The proposed remedy was developed by Con Edison after performing a detailed investigation of the site under NYSDEC's Voluntary Cleanup Program. The site transitioned to the New York State Superfund Program once the Voluntary Cleanup Program was terminated.

issue a final Decision Document. NYSDOH must concur with the proposed remedy. After approval, the proposed remedy becomes the selected remedy. A detailed design of the selected remedy will then be prepared, and the cleanup will be performed.	<u>MGP Program Overview</u> : New York's MGP Program oversees the investigation and cleanup of former MGP sites. Sites that pose a significant threat to public health and/or the environment go through a process of investigation, evaluation, cleanup and monitoring.
<ul> <li>NYSDEC will keep the public informed throughout the investigation and cleanup of the site.</li> <li>Site Description: The location of the former MGP is within the Cedar Street right of way and a portion of 47 Cedar Street which is currently used as a car dealership. The former MGP operated from 1863 to 1911 and was redeveloped in 1953 for automotive sales and repairs.</li> <li>Additional site details, including environmental and health assessment summaries, are available on NYSDEC's Environmental Site Remediation Database (by entering the Site ID, 360173) at:</li> <li><u>http://www.dec.ny.gov/cfmx/extapps/derexternal/index.cfm? pageid=3</u></li> </ul>	The gas manufacturing process involved the heating of coal and/or petroleum products to produce a gas mixture. Once cooled and purified, the gas was distributed through a local pipeline network. The gas was used for heating and cooking much like natural gas is used today. In the early years, the gas was also used for lighting in homes and in streetlights. A dense, oily liquid known as coal tar would condense out of the gas at various stages during its production, purification and distribution, and be discharged to the subsurface. NYSDEC attempts to identify parties responsible for site contamination and require cleanup before committing State funds. For more information about the MGPs, visit:
<b>Summary of the Investigation:</b> In 2013/2014, a remedial investigation of the former MGP was performed on behalf of Con Edison. The primary contaminants of concern at the site include PAHs and metals in subsurface soils (deeper than 5 feet below ground surface) and volatile organic compounds (VOCs) and semi-volatile organic compounds (SVOCs), in groundwater.	<u>http://www.dec.ny.gov/chemical/8430.html</u> We encourage you to share this fact sheet with neighbors and tenants, and/or post this fact sheet in a prominent area of your building for others to see.
As mentioned above, the "Remedial Investigation Report", which describes the results of the site investigation was submitted and is also available for review at the locations identified on Page 1. Based on the findings of the investigation, NYSDEC in consultation with the NYSDOH has determined that the site does not pose a significant threat to public health or the environment.
