Investigation to Begin at State Superfund Site

The NYS Department of Environmental Conservation (NYSDEC) will soon begin a detailed environmental study at the Irvington Rugs and Cleaners site ("site") located at 53 Main Street, Village of Irvington, Town of Greenburgh, in Westchester County. Please see the map for the site location.

Investigation Work Plan: The investigation work plan, called a "Remedial Investigation Work Plan (RIWP)," was developed under the New York's State Superfund Program. The site is listed as a Class "2" site in the State Registry of Inactive Hazardous Waste Sites list of State Superfund sites. A Class 2 site represents a significant threat to public health or the environment and, therefore, action is required. NYSDEC and the New York State Department of Health (NYSDOH) will oversee the investigation.

Highlights of the Site Investigation: The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Past investigations in the area have determined that chlorinated solvent contamination exists at and adjacent to the site. Tetrachloroethene (PCE) and its byproducts are present in the site's subsurface media. PCE is a contaminant often associated with dry cleaning operations.

Key components of the investigation work include:

- Installing and sampling groundwater and soil vapor borings to evaluate the extent of downgradient groundwater and soil vapor contamination;
- Collecting soil vapor samples, as well as sub-slab soil vapor and indoor air samples at several off-site locations; and
- Sampling existing groundwater wells and basement sump water to monitor impacts from areas of concern both on-site and off-site.

Next Steps: The information collected during the investigation will be summarized in a report. After the site investigation and report are completed, NYSDEC will conduct a "Feasibility Study." This study uses the data collected during the site investigation to develop and evaluate potential ways to clean up contamination related to the site. The information collected during the site investigation may also support the conclusion that no action, or no further action, is needed to address site-related contamination. NYSDEC will then develop a draft cleanup plan, called a "Proposed Remedial Action Plan." This plan describes the remedy preferred by NYSDEC or, if warranted, a proposal for no action or no further action.

The draft cleanup plan provides the rationale for the preferred remedy by discussing each alternative and the reasons for selecting or rejecting it. The goal of the plan will be to ensure the protection of public health and the environment. NYSDEC will announce the availability of the draft cleanup plan in a future fact sheet and will present it to the public for its review and comment during a 30-day comment period and at a public meeting.

Site Description: The site property comprises approximately 0.06 acres in the historic downtown district. The property is covered mostly by a one-story building that shares walls with mixed-use buildings on properties to the east and west of the site. The area to the rear (north) of the site building is paved. The site is bordered on the south by Main Street. The site building was constructed in the early 1900s, and it is estimated from historic records that the site has been used as a dry cleaner or dry cleaner drop-off location since approximately 1965. The property continues to operate as a dry-cleaning facility, although it no longer uses PCE.
