State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

- Site soil, groundwater, and surface water and the surface water of the adjacent White Plains Reservoir #2
 are contaminated with perfluorooctanoic acid (PFOA) and/or perfluorooctane sulfonic acid (PFOS) above
 standards, criteria, and guidance levels. PFOA and/or PFOS were also detected in sediment onsite and in
 Reservoir #2.
- Additional investigation is needed to define the nature and extent of site-related contamination; to evaluate
 associated human exposure pathways; and to determine the appropriate actions to prevent and mitigate
 potential exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.


