# State Superfund Site Reclassification Notice Class 2 to Class 4

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reasons:

- The on-site area was remediated by the in-situ (in place) stabilization of contaminated soils, in-situ
  groundwater treatment of contaminated groundwater, excavation and off-site disposal of soil exceeding
  commercial use soil cleanup standards, and the installation of a clean backfill cover over the stabilized
  and excavated areas.
- The off-site drainage swale was addressed by the excavation and off-site disposal of contaminated soil and the installation of a clean backfill cover.
- Human exposures to low levels of soil and groundwater contamination remaining at the site are being
  addressed through the implementation of an environmental easement. The easement restricts the use
  of the property to commercial or industrial use and prohibits the use of groundwater as a source of
  potable or process water.
- Compliance with the approved Site Management Plan and annual certification by the property owner to the DEC will ensure that the institutional and engineering controls remain effective.


