Investigation Completed at State Superfund Site; Interim Remedial Measure Proposed; Public Comment Period Announced

An investigation has been completed for the Former RKO Dry Cleaners site ("site") located at 566 Washington Avenue, Albany, Albany County. Please see the map for the site location. Documents related to the cleanup of this site can be found at the location(s) identified below under "Where to Find Information." The investigation was conducted by the responsible party with oversight provided by New York State Department of Environmental Conservation (NYSDEC).

NYSDEC has approved a report, called a "Remedial Investigation Report," that describes the results of the site investigation and recommends development of a remedy to address the contamination that was found.

Highlights of the Remedial Investigation Report

Former dry cleaning operations have impacted subsurface soils with chlorinated volatile organic compounds, including tetrachloroethene (PCE) at concentrations above restricted residential use soil cleanup objectives and protection of groundwater soil cleanup objectives. Groundwater has also been impacted with concentrations of PCE exceeding applicable groundwater standards. Indoor air impacts as a result of soil vapor intrusion have been mitigated in a nearby structure with the installation of a sub-slab depressurization system. During the Remedial Investigation additional indoor air and sub-slab vapor sampling was performed at two other structures, and it was determined that no additional mitigation was required.

The site is listed as a Class "2" site in the State Registry of Inactive Hazardous Waste Sites (list of State Superfund sites). A Class 2 site represents a significant threat to public health or the environment, therefore cleanup of site will be required to address remaining contamination of PCE in site soils which is contributing to elevated levels of PCE in site groundwater and soil vapor.

How to Comment

NYSDEC is accepting written comments about the proposed IRM work plan for 30 days, from **June 8, 2017** through **July 8, 2017**. The proposed plan is available for review at the location(s) identified below under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project Related Questions in the "Who to Contact" area below.

Draft Interim Remedial Measure Work Plan

An IRM is a cleanup activity that may be performed when a source of contamination or exposure pathway (the way in which a person may contact contamination) can be effectively addressed without extensive investigation and evaluation.

The draft IRM work plan includes the excavation and off-site disposal of subsurface soils which are contaminated with PCE at concentrations exceeding the applicable soil cleanup objectives and are impacting groundwater and soil vapor. An amendment to enhance the natural biodegradation already occurring will be mixed into soils at the bottom of the excavation to address residual contamination. Work is expected to begin in July.

Next Steps

A Feasibility Study will be conducted based on information obtained during the investigation and the Interim Remedial Measure to achieve the following:

- 1) define the objectives of the site cleanup program;
- 2) develop cleanup alternatives; and
- 3) screen and analyze the alternatives.

NYSDEC will then develop a draft cleanup plan, called a "Proposed Remedial Action Plan." This plan describes the remedy preferred by NYSDEC to address contamination related to the site. The draft cleanup plan will explain the decision that led to the preferred remedy by discussing each alternative and the reasons for choosing or rejecting it. The goal of the plan will be to ensure the protection of public health and the environment. NYSDEC will announce the draft cleanup plan in a future fact sheet and present it to the public for its review and comment during a 30-day comment period and at a public meeting.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Background

Location: The RKO Dry Cleaners site is located in the City of Albany at the intersection of Ontario St. and Washington Ave. It is bordered by Ontario St. to the west, Washington Ave. to the north, and residential structures to the east and south.

Site Features: The site, which is approximately 50 feet wide by 70 feet long, is currently a vacant lot covered with concrete and gravel. Until June 2012, a circa 1950 building was present on the property with an area of approximately 2,575 square feet. The building was a one-story structure with a flat roof and a basement beneath approximately half the building. A fire occurred at the building in 2000 that left charred wood on much of the interior of the structure and holes in the roof. The exterior of the building was subsequently boarded up. In June 2012, the building was razed due to safety concerns by Albany County. A small driveway exists on the east side of the site.

Current Zoning and Land Use: The site is currently vacant and is zoned for residential use. The surrounding area consists of a mix of residential and commercial properties.

Past Use of the Site: The property was developed as early as 1909. From 1964 to 2005, the site was occupied by RKO Dry Cleaners and Tailors, except for the year 1995 when Lee's Market was listed as the occupant. In December 2000, a large fire occurred at the site and a spill was called in (0010595) due to the presence of containers of dry cleaning chemicals which may have been spilled.

Site Geology and Hydrogeology: The geology of the overburden aquifer consists of generally brown, plastic clay that transitions into a mixture of silt and clay at approximately 7.5 feet to 10 feet below ground surface. Some fine sand layers were also encountered. Although bedrock was never encountered, the Phase I Environmental Site Assessment (ESA) indicated the bedrock is Normanskill Shale. Groundwater was encountered at approximately 9.5 feet below ground surface and flows toward the east, eventually discharging into the Hudson River.

State Superfund Program: New York's State Superfund Program (SSF) identifies and characterizes

suspected inactive hazardous waste disposal sites. Sites that pose a significant threat to public health and/or the environment go through a process of investigation, evaluation, cleanup and monitoring.

NYSDEC attempts to identify parties responsible for site contamination and require cleanup before committing State funds.




