Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). As of the date of this notice, the site identified above, and located on a map on the reverse side of this page, was added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

Past uses of the site have included the dumping/burying of wastes associated with metallurgical processes that occurred at the site and at nearby Al Tech Specialty Steel (east-southeast of site; see attached figure). These previous operations have resulted in contamination of soil and groundwater at levels exceeding applicable standards, criteria and guidance values. Based on the available data, and given that the subject property allows for future residential use and is adjacent to a residential area, there is a potential for people who access the site to be exposed to site-related contamination in on-site soil and groundwater. Additional actions are needed to define the nature and extent of contamination on and off of the site, as well as to evaluate and address potential human exposure to site-related contaminants.

DEC will keep you informed throughout the investigation and cleanup of the site.


