### State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the map included in this mailing, has been added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

- Past uses of the site have resulted in contamination of groundwater and soil. Applicable standards, criteria and guidance values are exceeded for per- and polyfluoroalkyl substances (PFAS). Additional investigations are needed to determine the nature and extent of contamination and the potential for human exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.

### Health Assessment

The site is completely fenced and guarded, which restricts public access. However, people who dig below the ground surface may come into contact with contaminants in subsurface soils. People are not drinking the contaminated groundwater because the area is served by a public water supply that is not affected by this contamination.

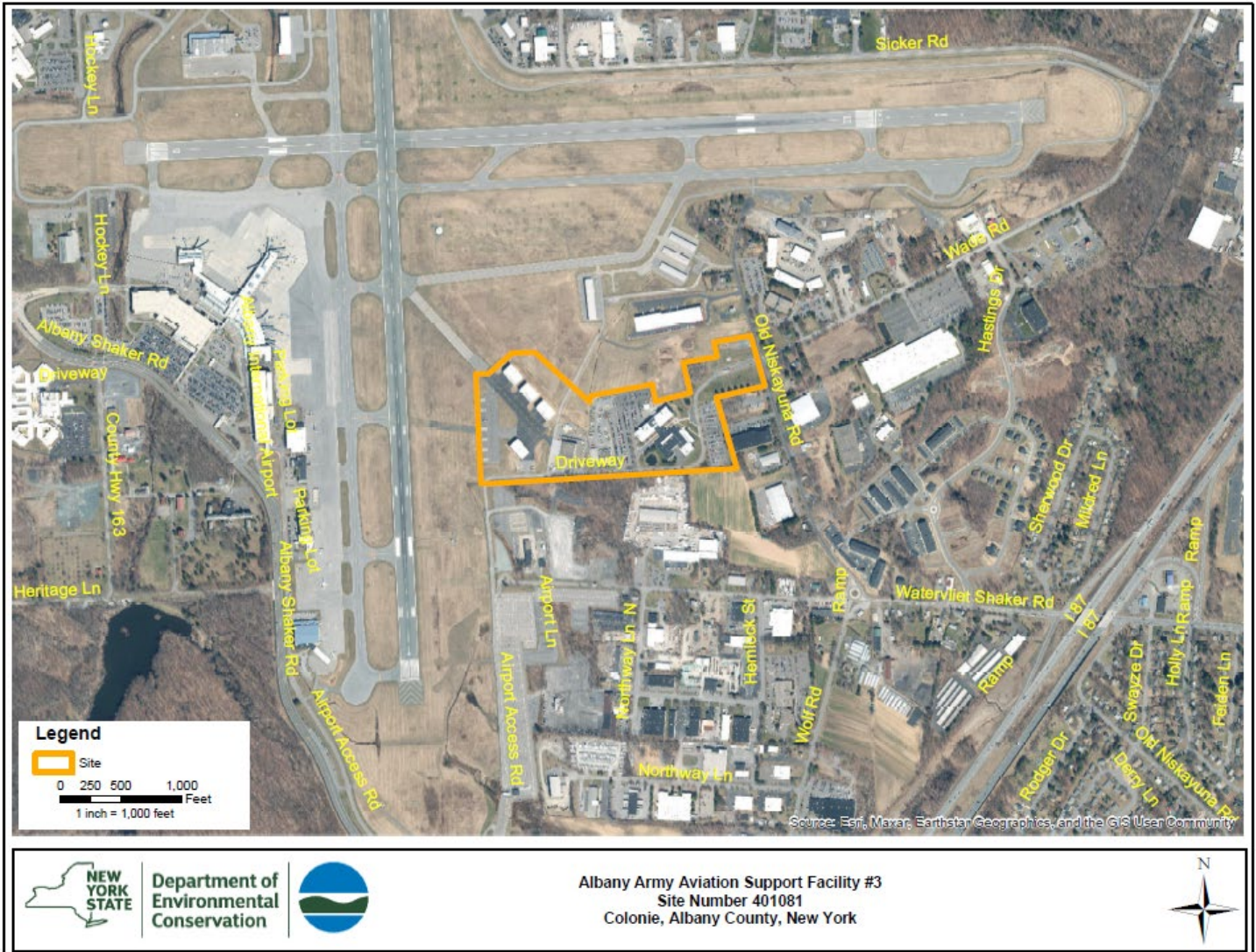
