# **State Superfund Site Classification Notice**

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 2 site that presents a significant threat to public health and the environment for the following reason(s):

Soil, groundwater, surface water and sediments are contaminated with volatile and semi-volatile organic
compounds, metals, polychlorinated biphenyls and per- and polyfluoroalkyl substances above applicable
Standards, Criteria and Guidance. Additional investigation is warranted to define the nature and extent of
site-related contamination, characterize potential human exposure pathways, and evaluate remedial
alternatives to eliminate the significant threat to public health and the environment.

DEC will keep you informed throughout the investigation and cleanup of the site.


